General Notes

1. The GDP used in the calculation of ratios refer to the Current Market Prices of the respective Member States.
2. The acronym MDC, as stated in Article 4 of the Revised Treaty of Chaguaramas Establishing the Caribbean Community including the CARICOM Single Market and Economy (Revised Treaty), refers to ***More Developed Countries*** namely Barbados, Guyana, Jamaica, Suriname and Trinidad and Tobago. The other Member States were designated as ***Less Developed Countries*** (LDC) according to the Revised Treaty.
3. This report covers data for seven of the nine member countries of the Organisation of Eastern Caribbean States (OECS). The countries not included are Anguilla and the British Virgin Islands which are Associate Members of the Caribbean Community.
4. Calculations at the levels of CARICOM, CSME, MDCs, LDCs and OECS, exclude those countries for which data may not be available.
5. The currency used is the Eastern Caribbean (EC) Dollar except for the Gross International Reserves and Gross Official Reserves tables which are presented in United States (US) Dollars. In most cases the data were originally extracted in the National currency and were converted to the EC dollar for comparison purposes. (US\$1.00 = EC\$2.70)

Preface

The first edition of this report started out simply as an attempt to make available for both internal and external users, key economic indicators of CARICOM Member States in a single publication. As the report developed and the problems of compiling a consistent and reliable data set across all Member States were exposed, the publication grew into an attempt to bring to the fore the issues of harmonisation of statistics in the Region.

Harmonisation of statistics demands, or necessitates, that we have common data with harmonised or equivalent definitions that can be reliably compared across all Member States. With the creation of the CARICOM Single Market and Economy (CSME), the achievement of harmonisation of statistics is a crucial concern at the Regional and National levels. The monitoring of the performance of the CSME is only possible if there is a core set of statistics that are comparable and timely. Hence, the analysis in this report takes the form of a presentation of the conceptual framework of the data to assess the current status of the economic statistical system and to identify the gaps and deficiencies that can militate against the achievement of this goal of harmonisation of statistics in the CARICOM Region. In addition, a study of some of the trends highlighted may lead to the question of data reliability and accuracy, which may stimulate the need to re-examine the data at the source.

It is obvious that a lot more work is required, but this publication makes an initial effort to embark on the task of going deeper into the methodologies in use in the Region, and producing a core set of socio-economic, environment and eventually a set of sustainable development statistics indicators.

*The Statistics Programme welcomes any suggestions as to how the issues highlighted in the **Notes about the Data** can lead to an improvement of the quality, comparability and availability in general of these statistics in the Region.*

DATA HIGHLIGHTS: 2009 AND 2010

Real GDP

In 2009, as a result of the global financial crisis, the economies of the region all recorded negative growth except for Guyana and Suriname, which grew at a rate of **3.3 percent** and **3.0 percent** respectively. The real GDP for region as a whole contracted by **-3.6 percent** over the previous year. The larger economies, Trinidad and Tobago and Jamaica, saw their real GDP decline by **-4.4 percent** and **-3.5 percent** respectively, while Antigua and Barbuda experienced the worse decline with a negative growth rate of **-12.0 percent** over 2008. Real GDP in the Organisation of Eastern Caribbean States (OECS), of which Antigua and Barbuda is a member, fell by **-5.2 percent** from the previous year.

In 2010, there was a slight recovery in the region's real GDP which grew by a miniscule **0.1 percent** from 2009. Guyana and Suriname continued to report growth, **4.4 percent** and **4.1 percent** respectively. In the case of the larger economies, there was a small growth of **0.2 percent** in Trinidad and Tobago but Jamaica continued to experience negative growth (**-1.5 percent**), albeit less than the previous year. The countries of the Organisation of Eastern Caribbean States (OECS) had a mixed performance but overall the grouping continued to decline at a rate of **-2.2 percent**.

Consumer Price Index

In 2009, Jamaica reported an annual average inflation rate of **10.2 percent**, the highest in the Region, followed by Trinidad and Tobago with **7.2 percent**.

In 2010, the situation worsened. The inflation rate in Jamaica moved to **11.7 percent** while in Trinidad and Tobago it was **10.6 percent**, increasing in both cases. In general, inflation rates increased across the Region in 2010; only in the Bahamas, Montserrat and St. Kitts and Nevis did it fall below the 2009 level in those countries.

Unemployment Rate¹

Based on available data, Saint Lucia had the highest unemployment rate in the Region in 2009 with **18.1 percent** of the labour force without jobs. In the Bahamas the unemployment rate for

the same year was **14.2 percent** while in Jamaica it was **11.3 percent**. Unemployment in Trinidad and Tobago was the lowest in the Region in 2009 at **5.3 percent**.

In Saint Lucia in 2010, the unemployment rate increased to **20.6 percent**. There was also an increase in Trinidad and Tobago's unemployment rate in 2010 moving to **5.9 percent**, while in Jamaica it rose to **12.4 percent**.

Structure of GDP

Industry as percentage of Country's GDP²

In 2009, the services sector was the most significant industry in all countries of the region accounting for over **50 percent** of each country's GDP and **71.8 percent** of the region's total GDP. In some countries, the services sector was as high as **96.2 percent** of GDP as was the case of the Bahamas. The contribution of services to the Barbadian economy was **91.0 percent** and in Jamaica it was **85.2 percent**. In the OECS sub-region as a whole, the industry accounted for approximately **89.1 percent** of the sub-region's GDP in 2009. Following services (**50.6 percent**), mining and quarrying (**34.3 percent**) and manufacturing (**17.9 percent**) were the next major industries in Trinidad and Tobago. In Guyana, agriculture (**20.6 percent**) and mining and quarrying (**14.2 percent**) were significant industries after services and in Suriname manufacturing (**22.0 percent**) and agriculture (**11.1 percent**) were major.

The situation in 2010 was unchanged in terms of structure of the economy. The services sector remained the largest contributor to economies of the region accounting for over **47 percent** of each country's GDP and for the region as a whole accounting for over **70 percent** of total GDP. In some countries, there was a marginal decrease in the contribution of services to GDP but this did not affect the overall structure. Even though there was a small drop in the contribution of services to the Trinidad and Tobago economy, it still remained the largest sector at **47.2 percent** followed by mining and quarrying (**32.5 percent**) and manufacturing (**23.0 percent**). In Guyana, mining and quarrying increased to **16.0 percent** of GDP while agriculture dropped to **18.3 percent**. The contributions of manufacturing (**22.7 percent**) and agriculture (**10.7 percent**) to Suriname's GDP were not significantly different from in 2009.

Industry as a percentage of CARICOM's GDP in the specific industry

Agriculture: The major contributors to agriculture GDP in the region in 2009 were Jamaica (**32.2 percent**), Suriname (**19.0 percent**) and Guyana (**17.4 percent**). In 2010, the top contributors remained unchanged with Jamaica (**32.8 percent**), Suriname (**19.7 percent**) and

Guyana (**16.6 percent**) together accounting for over 69 percent of the region's GDP in agriculture.

Mining and Quarrying: Trinidad and Tobago dominated this industry region-wide accounting for **89.3 percent** of the region's total mining and quarrying GDP in 2009. Suriname and Guyana followed at **3.9 percent** and **3.6 percent** respectively. Trinidad and Tobago's share fell marginally to **87.5 percent** in 2010, while Guyana and Suriname each contributed **4.3 percent** to the region's mining and quarrying GDP.

Manufacturing: In 2009, the countries contributing most significantly to the region's manufacturing GDP were Trinidad and Tobago (**54.1 percent**), Jamaica (**16.2 percent**) and Suriname (**12.9 percent**). By 2010, Trinidad and Tobago's share had increased to **60.5 percent** while Jamaica's dropped to **13.7 percent** and Suriname's slipped down to **12.2 percent**.

Services: Trinidad and Tobago was the leading contributor to CARICOM's GDP in services in 2009, this country's share of the region's services GDP was **25.5 percent**. This was followed by Jamaica with **24.5 percent** and The Bahamas at **18.9 percent**. In 2010, Jamaica was now the highest contributor accounting for **25.5 percent** of the region's GDP in services closely followed by Trinidad and Tobago with **24.6 percent**. The Bahamas remained virtually unchanged at **18.8 percent**.

Gross National Savings³

According to available data, the percentage of gross national savings to GDP was the highest in Antigua and Barbuda, accounting for **27.0 percent** of GDP in 2009. The Bahamas had the second highest ratio at **16.6 percent** of GDP followed by Saint Lucia with **16.1 percent**.

In 2010, the gross national savings was **22.2 percent** of Antigua and Barbuda's GDP, maintaining its position as the highest in the region. The ratio for the Bahamas fell to **13.7 percent** but in Saint Lucia it rose to **17.4 percent**.

Overall Fiscal Deficit/Surplus

There were only two countries which reported fiscal surpluses in 2009, these were Belize and Montserrat. In Belize the overall fiscal surplus was a mere **0.4 percent** of GDP while in Montserrat it was **3.6 percent** of GDP. Jamaica and Antigua and Barbuda had the highest deficits when measured as a percentage of GDP, recording **-11.4 percent** and **-11.0 percent** respectively.

In 2010, Belize's government operations had slipped into deficit, and stood at **-1.2 percent** of GDP. In Montserrat the surplus had decreased to **1.7 percent** of GDP. Both Antigua and Barbuda and Jamaica remained in deficit but this had decreased to **-1.4 percent** and **-6.3 percent** of their respective GDP. In addition to Montserrat, Trinidad and Tobago was only other member state to report a surplus in its central government operations, although this was only **0.1 percent** of GDP.

Merchandise trade balance

Except for Trinidad and Tobago and Suriname, the merchandise trade balance for all the other Member States was in deficit in 2009. Measured as a percentage of GDP, the merchandise trade balance was **11.6 percent** of Trinidad and Tobago's GDP in 2009 and **0.3 percent** of Suriname's. In 2008 the corresponding figures were 32.4 percent and 9.5 percent respectively, indicating a sharp decline in 2009 for both countries.

In 2010, Suriname's merchandise trade balance had rebounded to **15.8 percent** of its GDP while Trinidad and Tobago's almost doubled to **22.9 percent** of GDP. The merchandise trade balances of the other countries remained in deficit in 2010.

Current account balance

In 2009, Trinidad and Tobago and Suriname were the only CARICOM Member States that recorded a positive current account balance. However, in both countries this figure fell from the levels reported in 2008. In the case of Trinidad and Tobago, the current account balance measured as a percentage of GDP was **8.5 percent** in 2009, down sharply from the 30.3 percent reported in 2008, while in Suriname it stood at **2.9 percent** in 2009.

In 2010, these Member States were still the only two to report positive current account balances which had increased in both cases from the previous year. The current account balance to GDP ratio stood at **20.2 percent** in Trinidad and Tobago and **15.0 percent** in Suriname.

For both years, the OECS member countries all reported negative current account balance to GDP ratios that were in the double-digits.

External Debt Outstanding

In 2009, at **75.3 percent**, Belize had the highest outstanding external public debt to GDP ratio in the region (based on available data which excludes Guyana and St. Kitts and Nevis). This was followed by Grenada with **70.9 percent** and Jamaica with **54.2 percent**.

Even though it was marginally less than in 2009, this ratio remained high in Belize in 2010 at **72.0 percent**. In the same year, the ratio rose to **72.7 percent** in Grenada while in Jamaica it increased to **61.3 percent**.

Debt Service Ratio

Based on available data which excludes Grenada, Guyana and St. Kitts and Nevis, the debt service ratio in the region was highest in St. Vincent and the Grenadines at **15.1 percent** in 2009. Dominica reported **11.7 percent** and in Belize it was **11.1 percent**. These were the only countries where the debt service ratio was over **10 percent**.

In 2010, the debt service ratio in St. Vincent and the Grenadines rose to **16.4 percent** and Dominica's went up to **12.3 percent**. Belize's debt service ratio fell in 2010 to **9.2 percent**. Two additional countries reported double-digit debt service ratios in 2010, Barbados (**11.1 percent**) and Jamaica (**11.7 percent**). Trinidad and Tobago and Suriname had the lowest debt service ratios in the region in 2010, both reporting **1.0 percent**.

Domestic Credit to the Private Sector

At the regional level, domestic credit to the private sector was **38.7 percent** of the region's total liabilities in 2009. In the Bahamas, domestic credit to the private sector was **65.5 percent** of that country's total liabilities while in Belize it was **56.7 percent** and **43.9 percent** in Barbados.

In 2010, the ratio at the regional level slipped to **37.3 percent**. In the Bahamas it decreased to **62.0 percent** and in Belize and Barbados, it was **55.6 percent** and **44.5 percent** respectively.

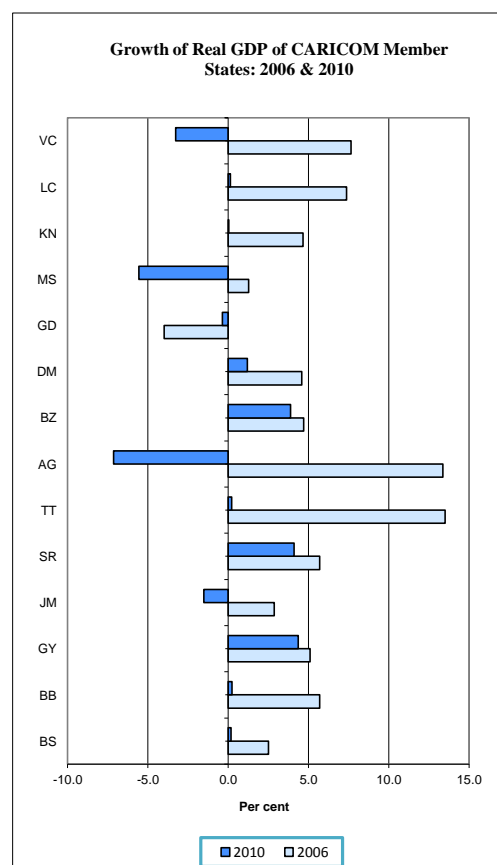
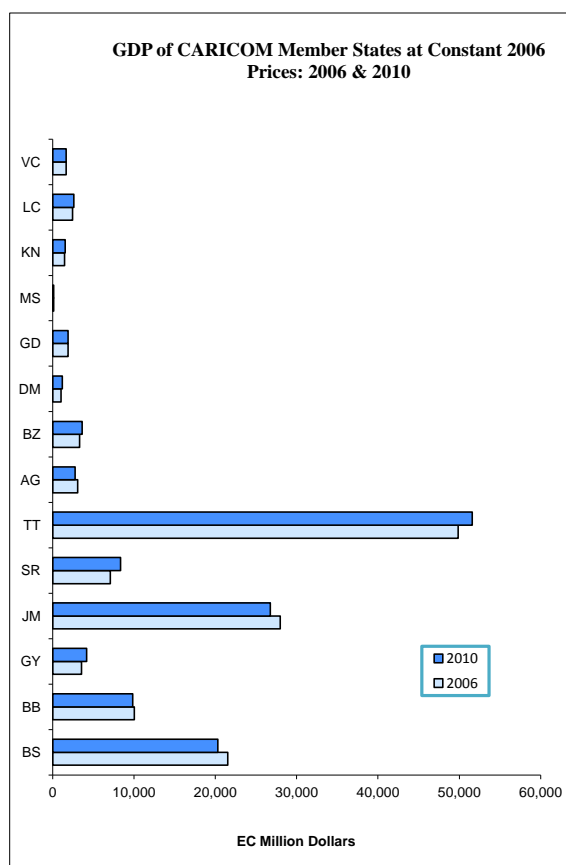

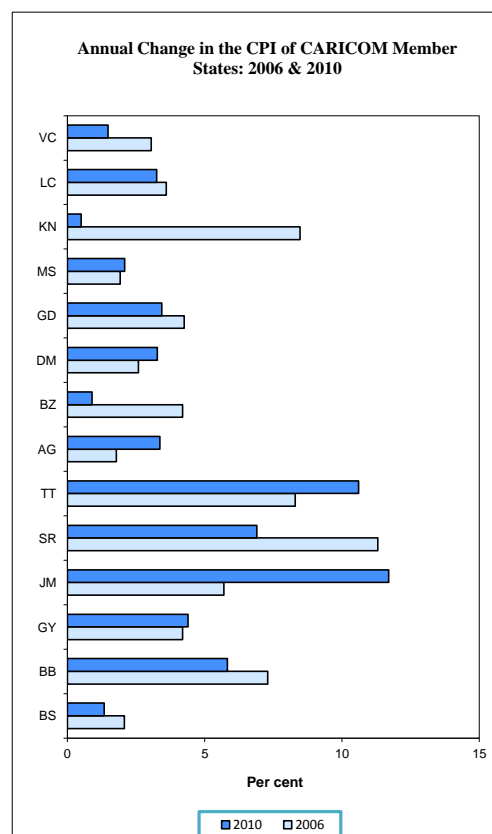
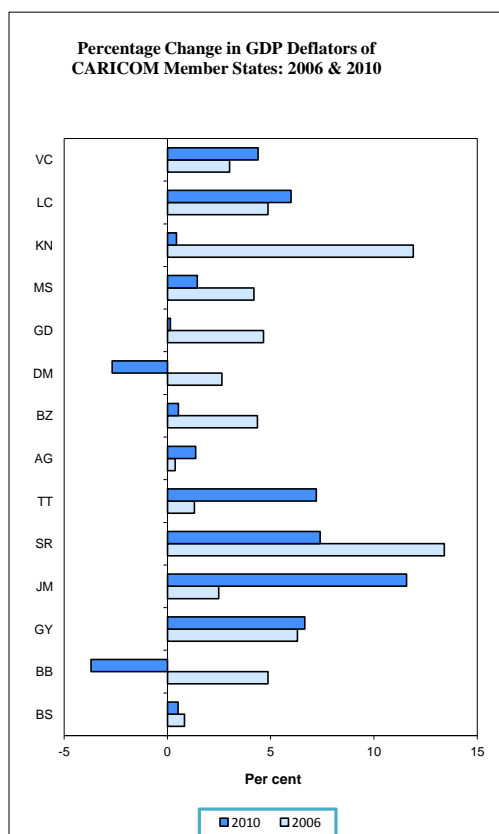
GNI of CARICOM, MDCs and LDCs: 2006-2010



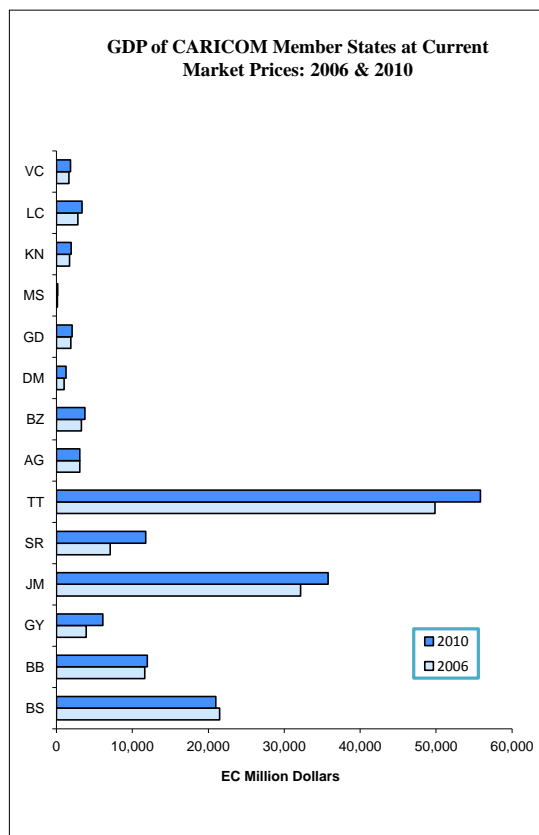

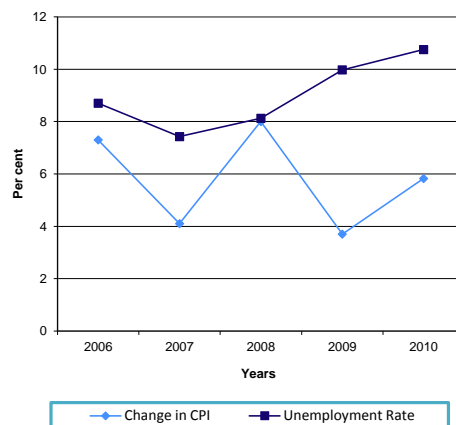




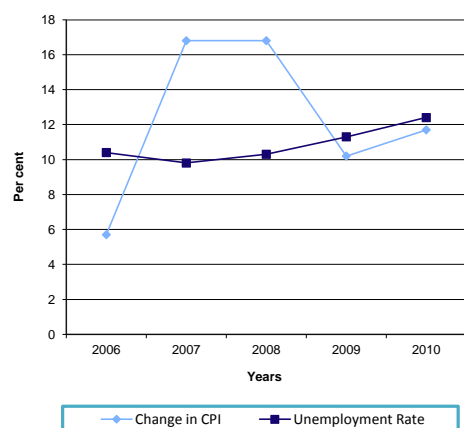
The Bahamas' Unemployment Rate and Annual Change in the CPI: 2006-2010



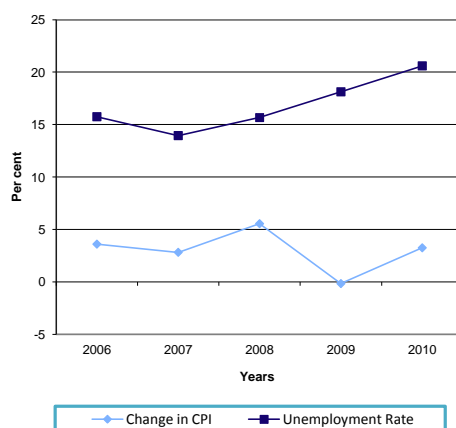
Barbados' Unemployment Rate and Annual Change in the CPI: 2006-2010



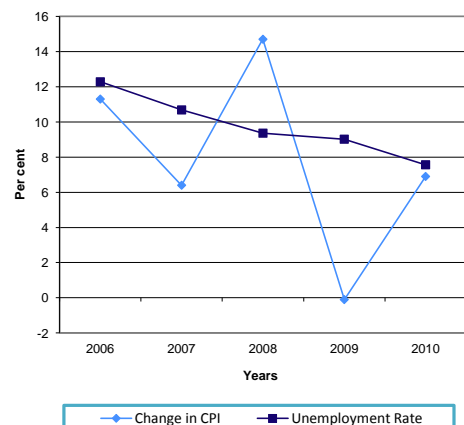
Jamaica's Unemployment Rate and Annual Change in the CPI: 2006-2010



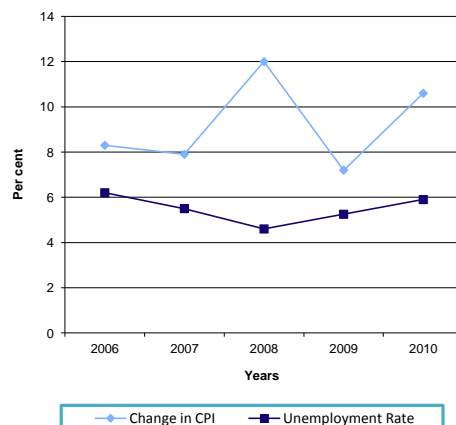
Saint Lucia's Unemployment Rate and Annual Change in the CPI: 2006-2010



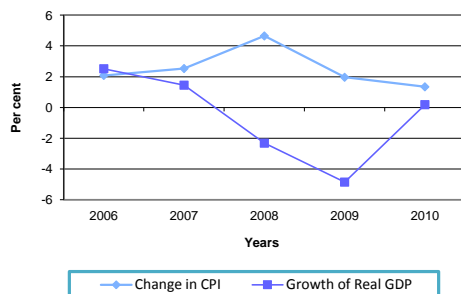
Suriname's Unemployment Rate and Annual Change in the CPI: 2006-2010



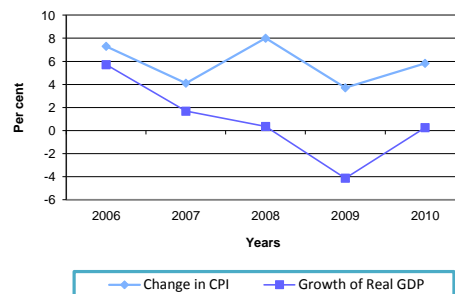
Trinidad and Tobago's Unemployment Rate and Annual Change in the CPI: 2006-2010



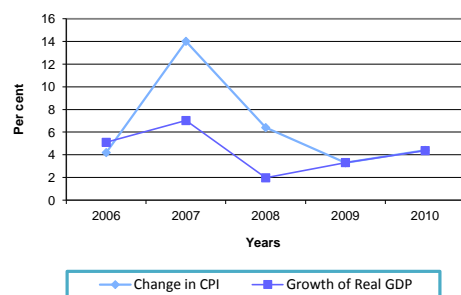
The Bahamas' Annual Change in the CPI and Growth of Real GDP: 2006-2010



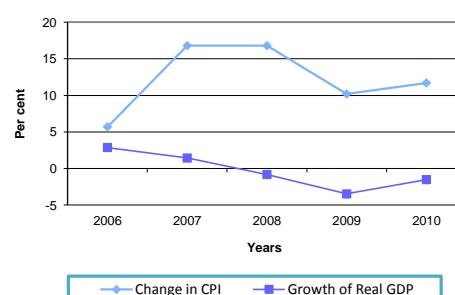
Barbados' Annual Change in the CPI and Growth of Real GDP: 2006-2010



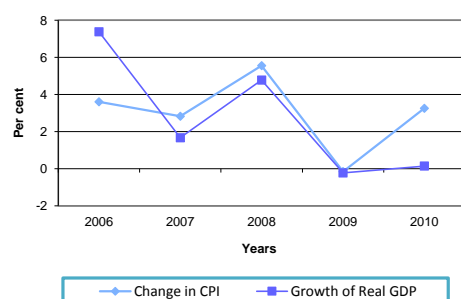
Guyana's Annual Change in the CPI and Growth of Real GDP: 2006-2010



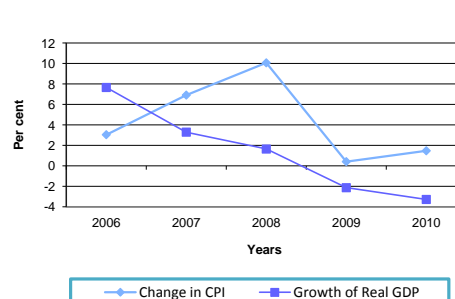
Jamaica's Annual Change in the CPI and Growth of Real GDP: 2006-2010



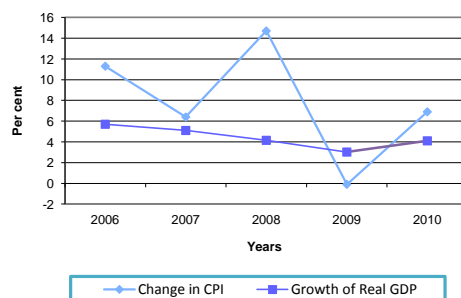
Saint Lucia's Annual Change in the CPI and Growth of Real GDP: 2006-2010



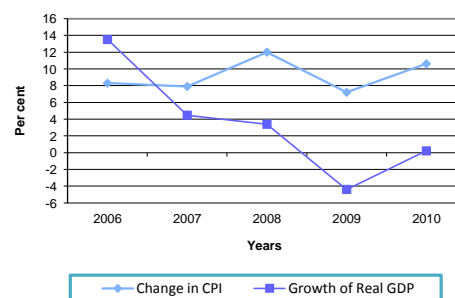
St. Vincent & the G'Dines' Annual Change in the CPI and Growth of Real GDP: 2006-2010



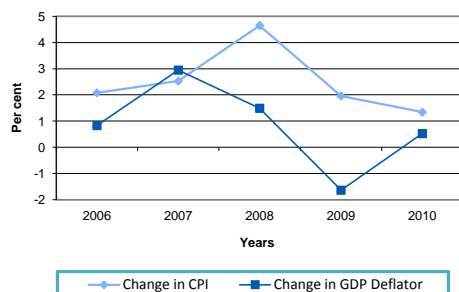
Suriname's Annual Change in the CPI and Growth of Real GDP: 2006-2010



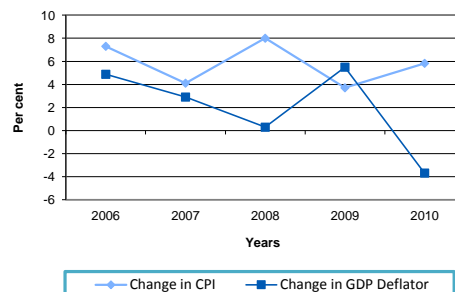
Trinidad & Tobago's Annual Change in the CPI and Growth of Real GDP: 2006-2010



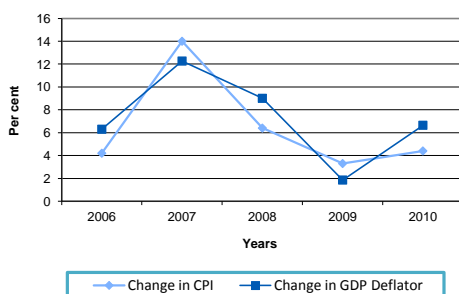
The Bahamas' Annual Changes in the CPI and GDP Deflator: 2006-2010



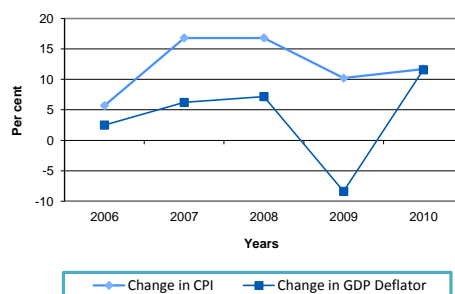
Barbados' Annual Changes in the CPI and GDP Deflator: 2006-2010



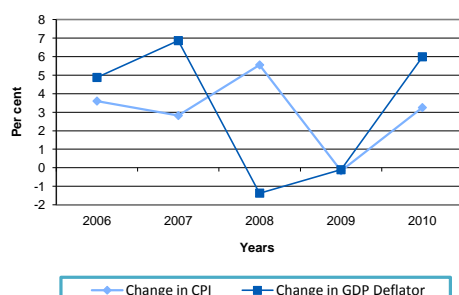
Guyana's Annual Changes in the CPI and GDP Deflator: 2006-2010



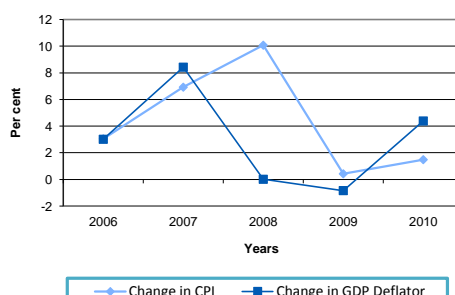
Jamaica's Annual Changes in the CPI and GDP Deflator: 2006-2010



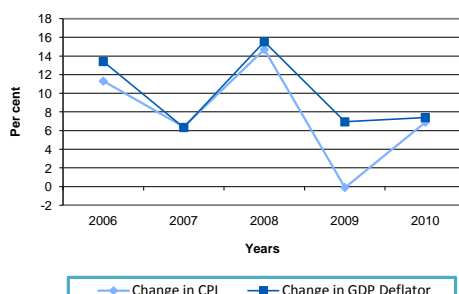
Saint Lucia's Annual Changes in the CPI and GDP Deflator: 2006-2010



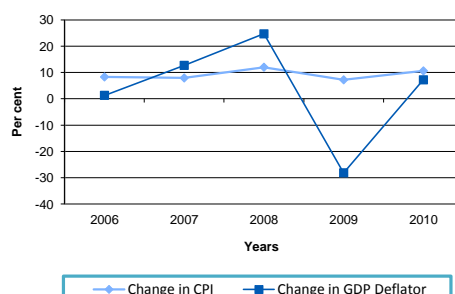
St. Vincent & the G'Dines' Annual Changes in the CPI and GDP Deflator: 2006-2010

Notes about the Data

Gross Domestic Product

Gross Domestic Product (GDP) at constant prices has been prepared at various base years across the Region. For Barbados it was prepared at constant 1974 prices; Belize and Trinidad and Tobago are at base year 2000; the Bahamas, Guyana and the Organisation of Eastern Caribbean States (OECS) member countries are at 2006 prices, while Jamaica and Suriname both use the year 2007. In the case of Guyana and Suriname, only data from 2006 onwards were reported at the new base years; data prior to 2006 were reported in the earlier base years, i.e. 1988 and 1990 respectively.

In an effort to arrive at regionally comparable data, except for those countries with base year 2006, the constant price data for all the other countries have been arithmetically recalculated from their respective base years to the year 2006. This approach of deriving a common base year is a 'second best' method. Ideally, the best approach would be to use the detailed price and quantity measures at the individual country level to re-base the GDP at constant prices.

Although the base years have been standardized in this report, the data at constant prices are still not totally comparable. Antigua and Barbuda, The Bahamas, Belize, Dominica, Grenada, St. Vincent and the Grenadines, Suriname and Trinidad and Tobago have all prepared the constant price GDP data in Market Prices while estimates for the other countries are at constant Basic Prices or Factor Cost. At current prices, all the countries reported the data in Market Prices.

Conversion of the data from national currencies to Eastern Caribbean (EC) dollars for the non-OECS Member

States generates the problem of annual changes at constant prices being larger than the corresponding changes at current prices for specific Member States. In addition, relative changes in current prices between Member States are affected by the uncoordinated movements between changes in exchange rates and prices. There were also differences in changes in current prices in EC dollars as compared to similar changes in national currency of the affected country.

Growth of Real GDP

Growth rates were calculated as the annual change in the real GDP in Constant 2006 prices. Since the shift in the base years was calculated arithmetically for those countries with base years other than 2006, these would not differ from the growth rates derived using the national base years. However, as noted above, in the case of Guyana and Suriname both of which adopted new base years but without extending the new series backwards, the growth rates for 2002 and 2006 for these two countries would not be strictly comparable with the rest of the series. This issue extends to the groups, CARICOM, CSME and MDCs, where the growth rates for 2002 and 2006 would not be comparable with the rest of the series. In this case, the rates were calculated using data previously reported by member states that were consistent across the years. Growth of real GDP per capita would be affected similarly for these two years.

Gross National Income

Gross National Income (GNI) data are presented in Market Prices for all Member States.

GDP Deflators

Caution should be exercised when attempting to interpret the changes in

the GDP deflators. Again, because some countries reported their constant GDP data in Basic Prices while others prepared theirs in Market Prices, the changes at the CARICOM and MDC group levels and individual country levels for some countries are therefore not entirely comparable.

Consumer Price Index

The data presented on Consumer Prices represent the inflation rates of Member States as measured by the percentage changes in the annual average CPI of the respective Member State. In the case of Guyana, the data refer to the percentage change in the end of period CPI.

It should be noted that differences in the Consumer Price Indices exist across Member States relative to the base year of the indices, the composition of the basket of goods and the geographic area covered within countries. In some instances, the price data reflect only one part of the country, for example, urban areas, or just one city. For example, the CPI data for Suriname refer to Paramaribo and Wanica districts only while in the case of Guyana, the data refer to the capital city, Georgetown. However, due to the relatively small size/population of the CARICOM Member States, the annual changes are taken as being representative of the entire country. It may be the case, however, that in rural areas, prices are higher and these are not reflected in the index.

In some Member States, the CPI is known as the Index of Retail Prices or Retail Price Index.

Unemployment Rates

Labour Force data are compiled from surveys conducted by the Member States. However, not all countries conduct regular surveys. In fact, for

some countries, the only data on employment that are available are derived from the decennial population censuses.

There are differences in the reference periods among Member States for the measurement of economic activity. The size of the Labour Force will also depend on the time of the year when the survey was conducted, which implies that seasonality could affect the data. Some countries conduct quarterly surveys and in these cases the average of the four quarters was used for the annual figure.

In addition, some Member States use the population '15 years and over' to measure economic activity while others use the '14 years and over' age group.

Concepts and Definitions

Real Gross Domestic Product

The Gross Domestic Product (GDP) is the total market value of goods and services produced in the country within a given period of time, after deduction of the cost of goods and services used up in the process of production, but before deduction of allowances for the consumption of fixed capital. It is the sum of the gross value added by all resident and non-resident producers in the economy plus any taxes minus subsidies not included in the value of production.

Gross National Income Per Capita

Gross Domestic Product plus net income from abroad equals the gross national income (GNI). GNI per capita is the total gross national income divided by the estimated total mid-year population.

GDP Implicit Price Deflator

The GDP implicit price deflator is the ratio of current prices over constant prices expressed as a percentage. This is one measure of general price changes in the economy, taking into account changes in the prices of all the final demand categories such as government consumption, capital formation, international trade and private final consumption expenditure.

Consumer Price Index

The Consumer Price Index (CPI) is a measure designed to monitor the changes in the prices prevailing in an economy based on a fixed basket of goods and services usually from one month to the next and sometimes based on a defined group of households or persons. It is a reflection of changes in prices as they affect the average consumer in the acquisition of goods and services.

Unemployment Rate

The unemployment rate measures the total unemployed as a percentage of the total labour force during a defined reference period.

Sources of Data

National Accounts data were compiled from data produced by the National Statistics Offices (NSOs) of the Member States and for the most part were submitted through the use of the United Nations National Accounts Questionnaires (NAQ).

Data on Prices were extracted from web sites and publications/bulletins prepared by the NSOs and/or Central Banks of the respective Member States.

Labour Force data were submitted directly from the NSOs or were extracted from the NSOs' publications and web sites.

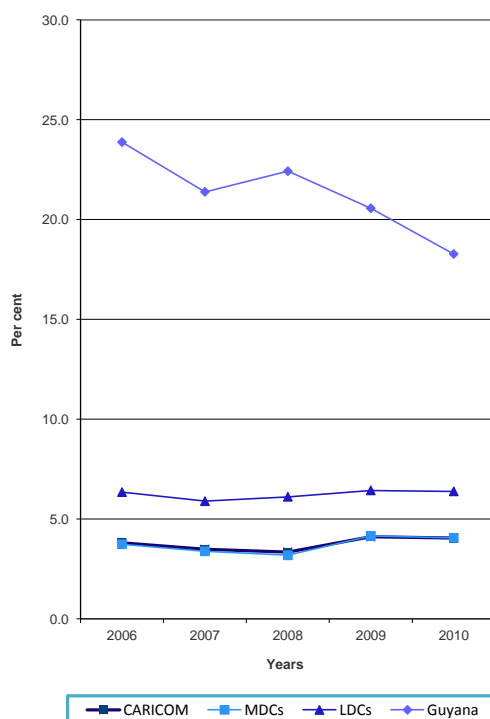

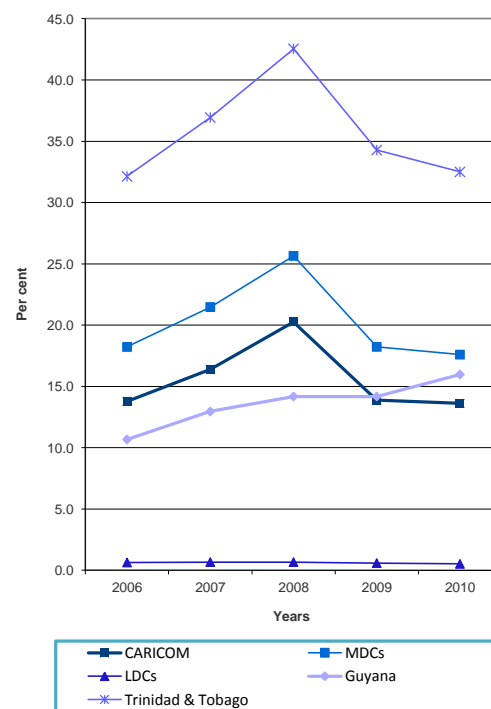

GDP: 2006-2010

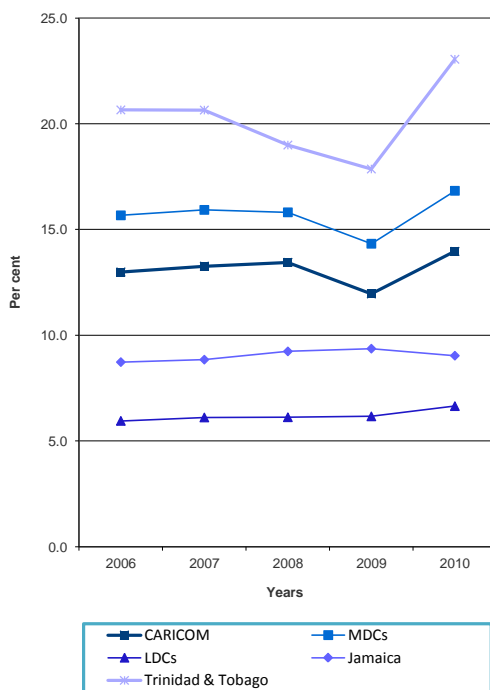


CARICOM, MDCs, LDCs, Guyana and Trinidad

to their Respective GDP: 2006-2010

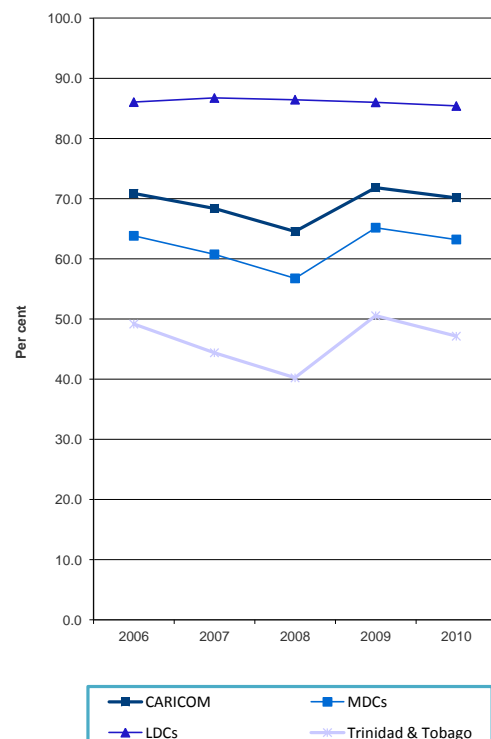

CARICOM, MDCs, LDCs, Jamaica and Trinidad & Tobago's Contribution of Manufacturing to their Respective GDP: 2006-2010

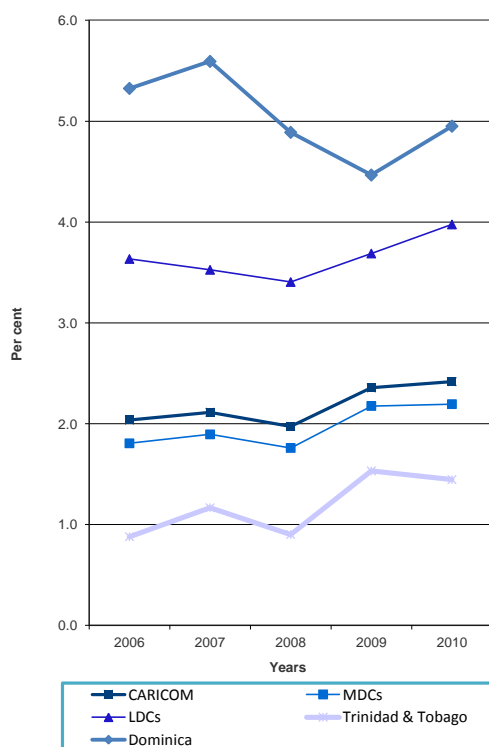


CARICOM, MDCs, LDCs, Guyana and Trinidad & Tobago's Contribution of Services to their Respective GDP: 2006-2010

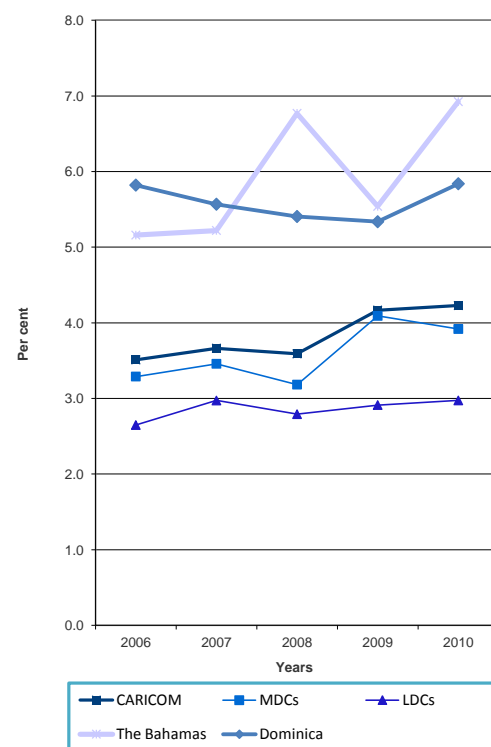

Respective GDP: 2006-2010

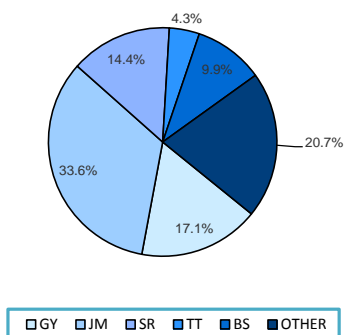

Respective GDP: 2006-2010

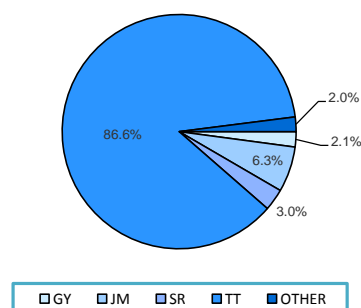

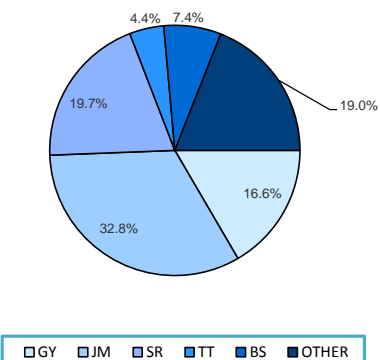
Member States Contribution to CARICOM's Total Agriculture GDP, 2006



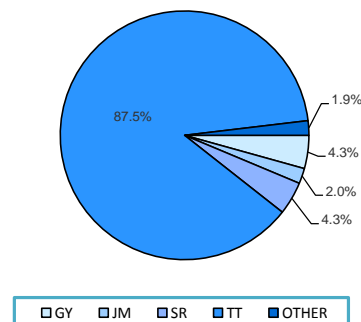
Member States Contribution to CARICOM's Total Mining & Quarrying GDP, 2006



Member States Contribution to CARICOM's Total Agriculture GDP, 2010

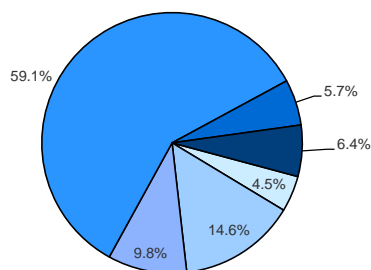


Member States Contribution to CARICOM's Total Mining & Quarrying GDP, 2010

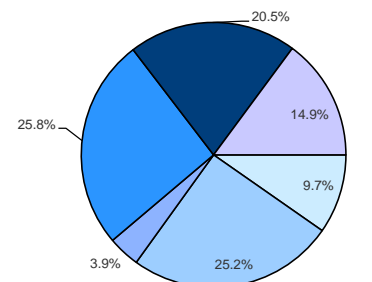

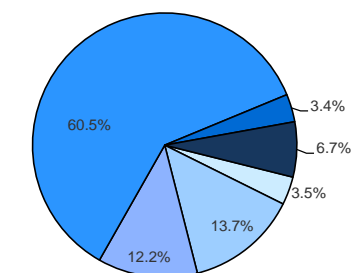
Member States Contribution to CARICOM's Total Manufacturing GDP, 2006



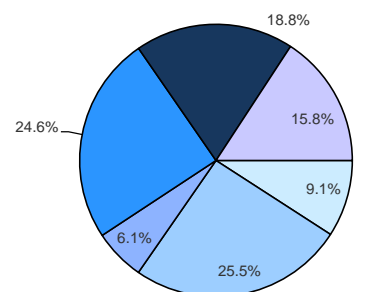
Member States Contribution to CARICOM's Total Services GDP, 2006



Member States Contribution to CARICOM's Total Manufacturing GDP, 2010

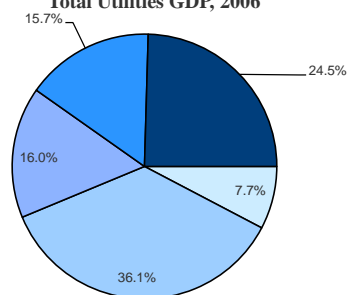


Member States Contribution to CARICOM's Total Services GDP, 2010

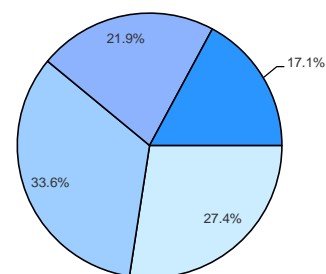

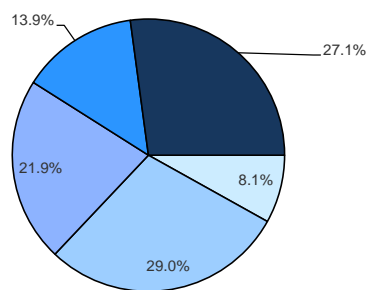
Member States Contribution to CARICOM's Total Utilities GDP, 2006



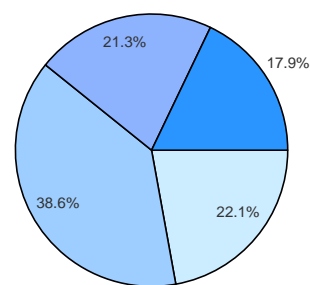
Member States Contribution to CARICOM's Total FISIM, 2006

Member States Contribution to CARICOM's Total FISIM, 2010



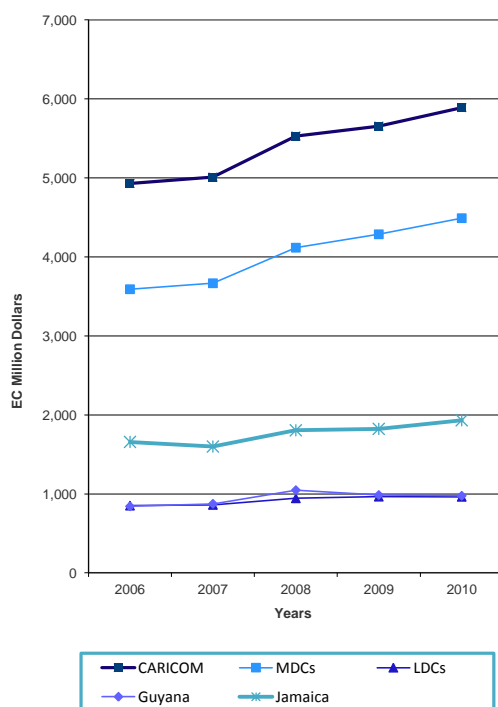

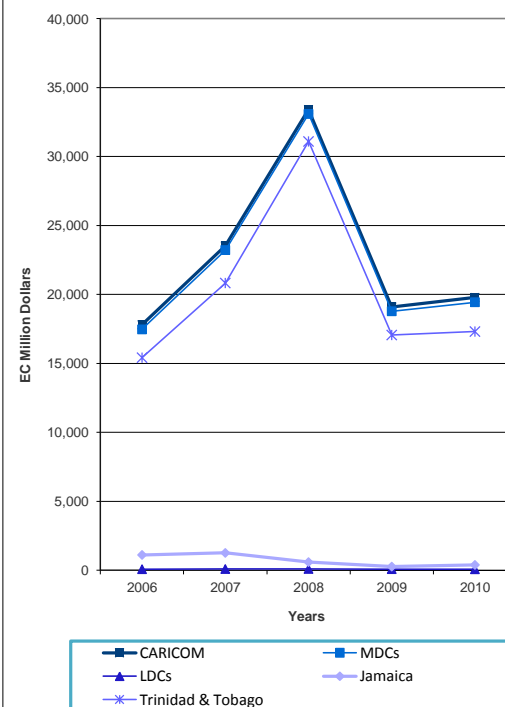

Value of CARICOM, MDCs, LDCs, Guyana and Jamaica's Agriculture Sector GDP: 2006-2010

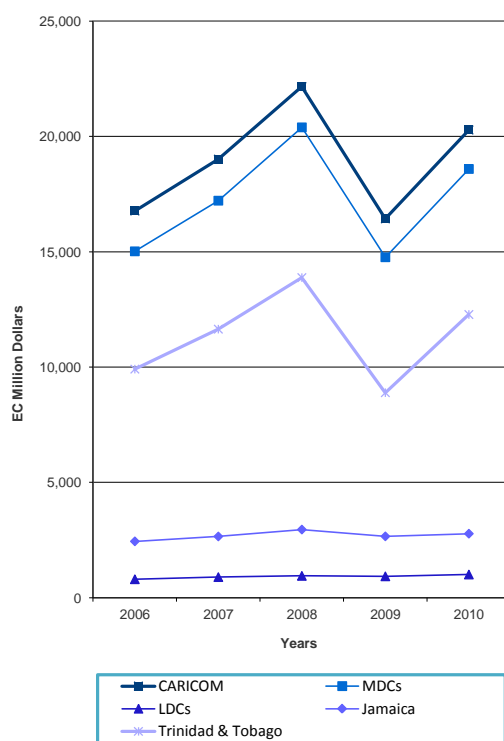


Value of CARICOM, MDCs, LDCs, Jamaica and Trinidad & Tobago's Mining and Quarrying Sector GDP: 2006-2010

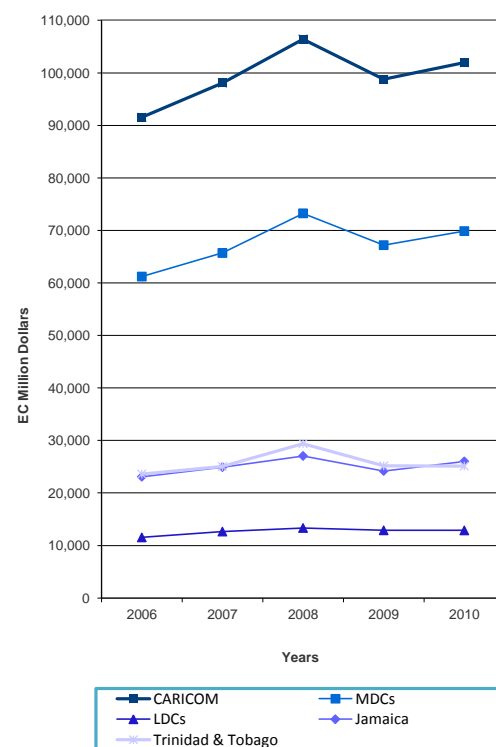

2010

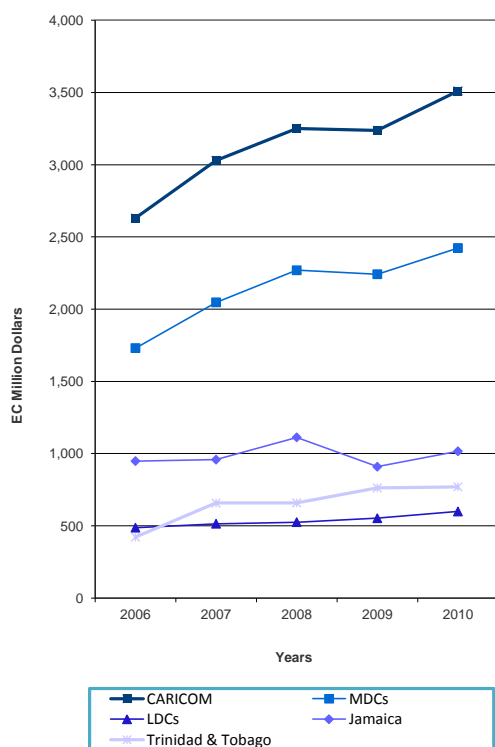

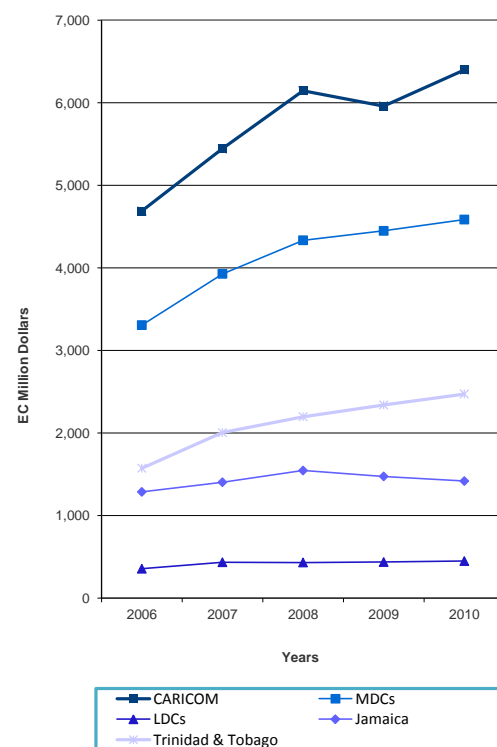

Notes about the Data

Output by industrial origin is classified according to the International Standard Industrial Classification (ISIC). Member States have been using adaptations of either the ISIC revision 2 or revisions 3/3.1. For the purpose of this report, **Agriculture** includes hunting, forestry and fishing while **Services** comprises construction, distribution, financial services, government services, hotels and restaurants, transportation and communication, personal and community services and other general services. **Utilities** refers to electricity, gas and water. In the case of Guyana, prior to 2006, *Electricity, gas and water* was included in the *Other personal and community services* category and therefore could not be disaggregated. For the period 2007-2010, **Construction** data for Trinidad and Tobago are included in *Mining and Quarrying*.

It should be noted that prior to the re-basing of Suriname's GDP series to the year 2006, data on the informal sector were identified separately in the GDP. For this report, the informal sector has been included in **Services** for the year 2002.

The first six tables presented in this section give a broad indication of the structure of the economy of each CARICOM country by major industry group. In calculating the percentages of the major industries out of the country's GDP, the value for the Financial Intermediation Services Indirectly Measured (FISIM) is subtracted from the industry total.

According to the System of National Accounts (SNA), FISIM should be distributed to the industries. However, Suriname was the only country that implemented this recommendation; data at the industry level for all the other countries include FISIM. Hence, for each country, the total of the five major industrial sectors less FISIM

will add to 100 percent. Only in Suriname's case do the five sectors add to 100 percent.

The next six tables present data on the percentage contribution of the five broad industrial sectors and the FISIM of each Member State to CARICOM's total GDP of the corresponding sector and FISIM. The final six tables provide the absolute values in EC dollars.

The reader should note that these indicators would also be affected by the limitations concerning exchange rate conversions as mentioned in the previous Section of this report.

Concepts and Definitions

Value Added/Output

Gross Output of industries is defined as the total value of all goods and services produced during the accounting period, adjusted for change in stock of work-in-progress and finished goods. Intermediate consumption consists of non-durable goods and services, which are used up in production. Value added at market prices is equal to the Gross Output at producers' prices less the value of intermediate consumption at purchasers' prices. The structure of production shows the breakdown of GDP through the contribution of agriculture, industry and services.

Sources of Data

The structure of GDP was calculated from data compiled by the National Statistics Offices of the Member States and submitted to the Secretariat.

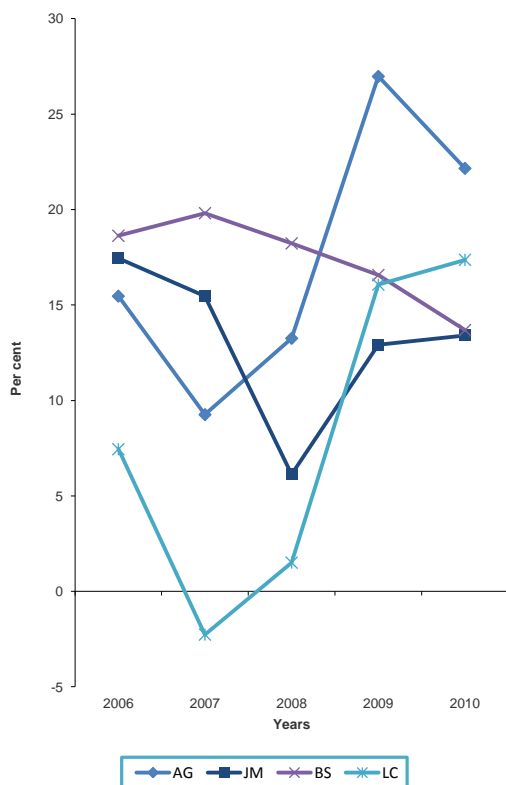

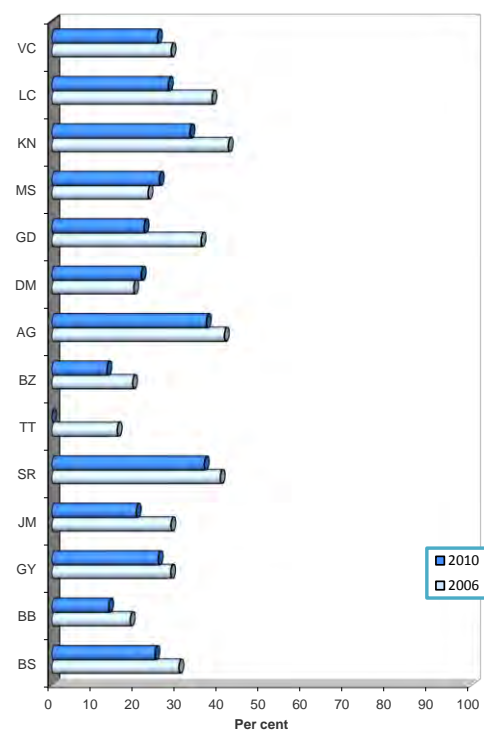

Gross Capital Formation as a % of each Country's GDP: 2006 & 2010

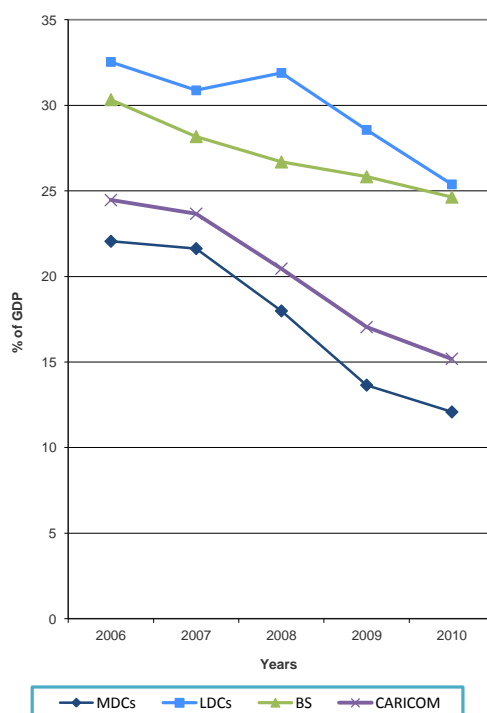
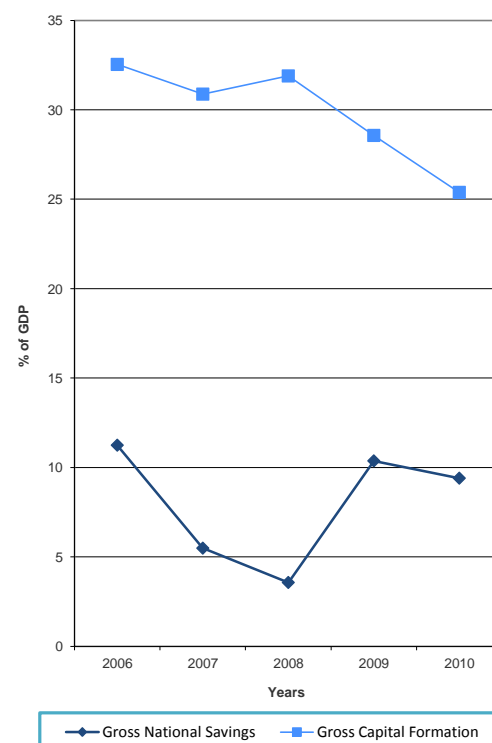

Notes about the Data

There are three approaches for compiling GDP estimates – production, expenditure and income. The tables presented in the previous section of this report were compiled from data based on the production approach. In this section, the data were compiled from the Expenditure tables of Member States as well as the National Aggregates of the countries.

Sources of Data

Extracted from the National Accounts data compiled by the National Statistics Offices of the Member States.

Concepts and Definitions***Gross National Savings***

Savings can be defined as disposable income which is not spent on consumption goods. That is, Disposable Income (National Income plus net transfers from the rest of the world) minus Final Consumption Expenditure (private plus government). The concept of Gross Domestic Savings differs from that of National Savings by not taking into consideration net factor payments from abroad (compensation to employees receivable from abroad and property income receivable from abroad) before subtracting final consumption expenditure.

Gross Domestic Investment

Gross Domestic Investment is gross fixed capital formation and increases in stocks. Gross fixed capital formation consists of outlays and additions to the fixed assets of the economy such as land improvement, plant, machinery and equipment and construction with respect to buildings, residential and commercial, roads, bridges, schools, private dwellings, etc.

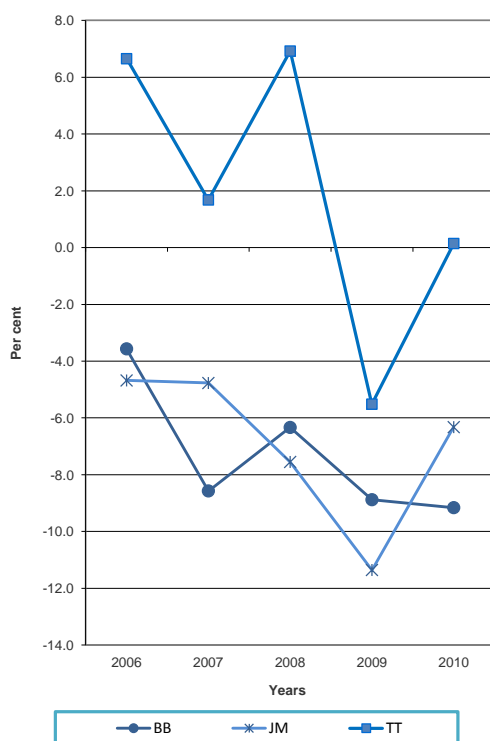
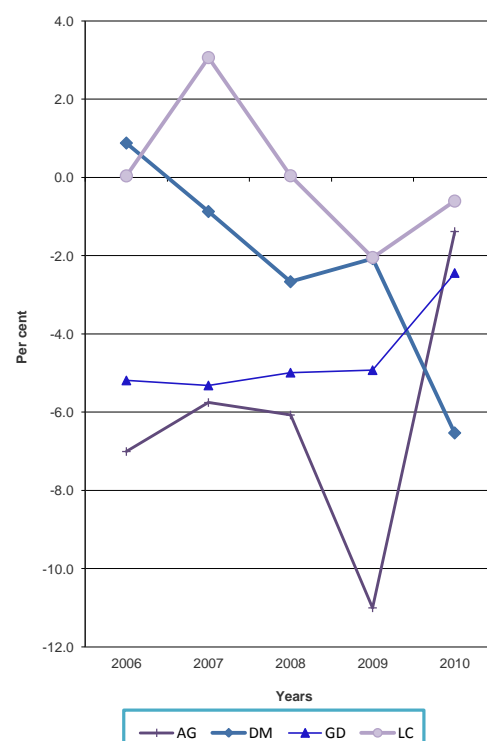

Overall Fiscal deficit/surplus (EC\$ Mn)

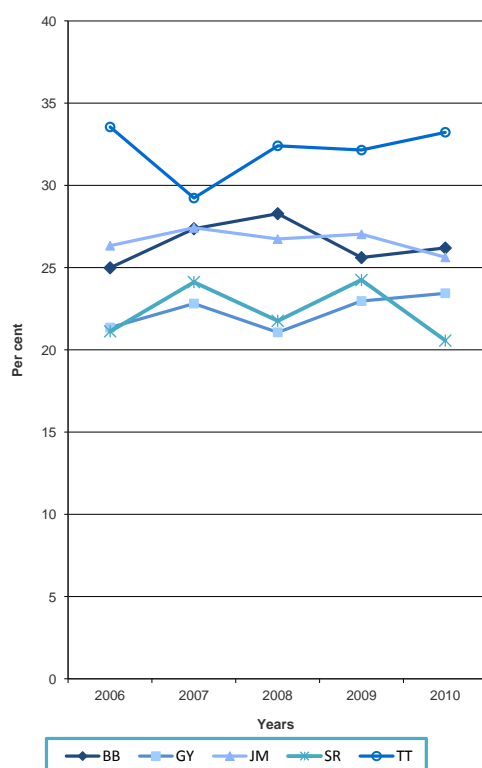

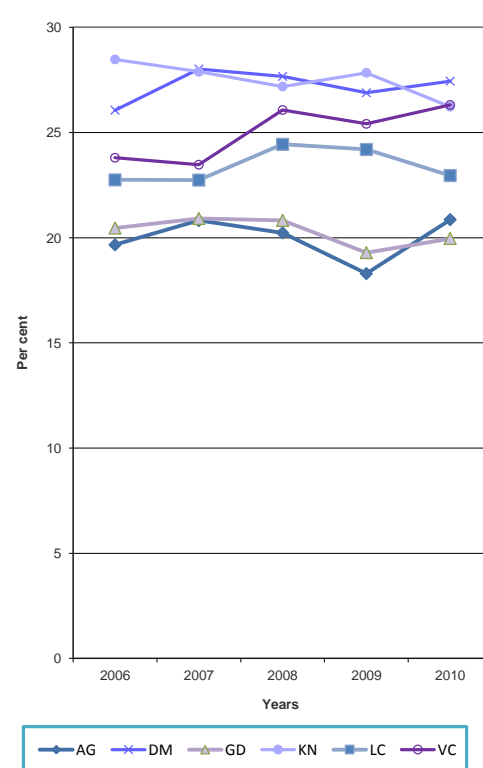

MDCs' Central Government Current Revenue as % of Country's GDP: 2006-2010

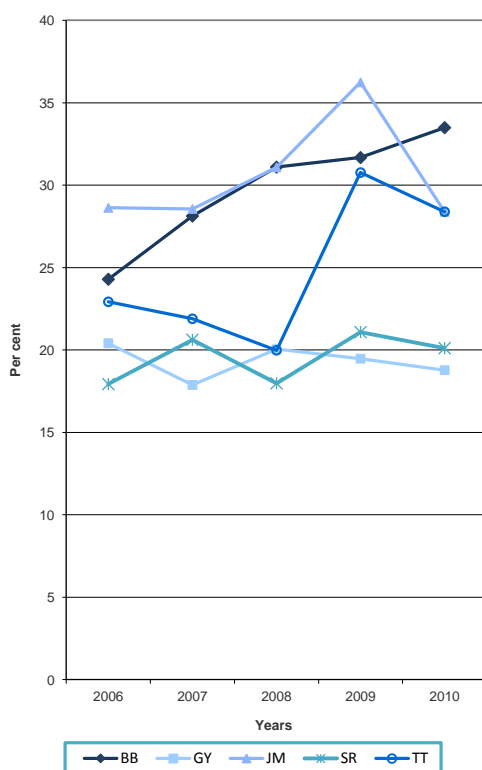

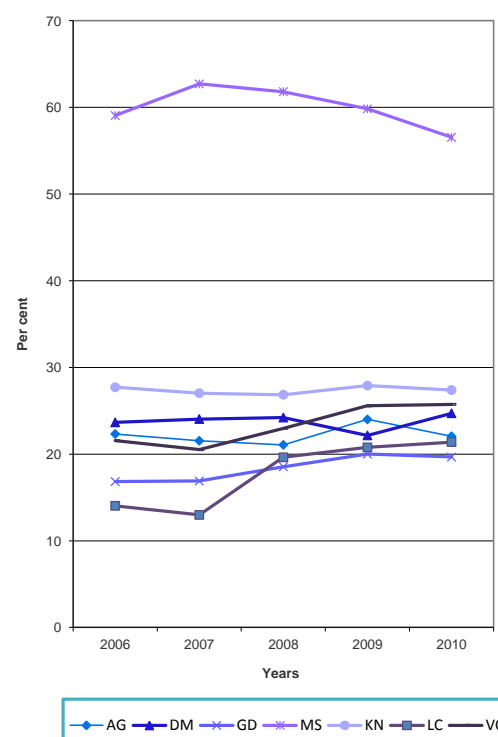

MDCs' Central Government Current Expenditure as % of Country's GDP: 2006-2010

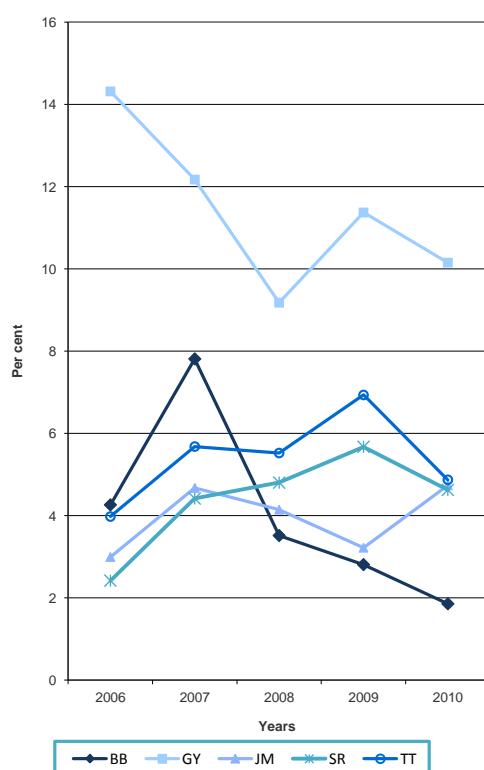


Selected LDCs' Central Government Current Expenditure as % of Country's GDP: 2006-2010

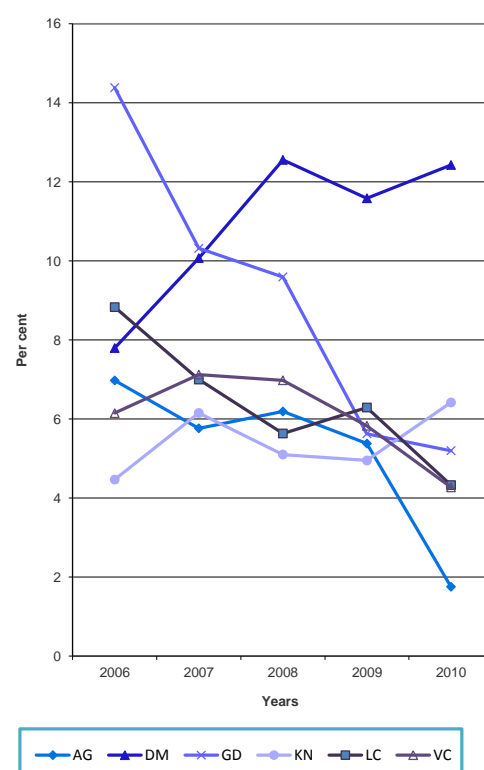

Notes about the data

Government budgetary operations are often based on a fiscal year, which may not always correspond with the calendar year. For all of the countries, except the Bahamas, Barbados, Belize, Jamaica and Trinidad and Tobago, the data extracted from the national sources were already reported in calendar years. In order to ‘fit’ the data for the other countries into calendar years, the data were placed in the year for which the larger part of the year applied. For example, if the fiscal year ran from April Year X to March Year Y, as in the case of Barbados, Belize and Jamaica, then the figures were placed in Year X. The Bahamas’ fiscal year, however, runs from July to June. In this case, the data were placed in the year containing the July to December data.

Concepts and Definitions***Government Current Revenue***

Current revenue of government consists of tax revenue and non-tax revenue but excludes capital receipts. Tax revenue covers taxes on income, profits, social security contributions, taxes on property, domestic taxes on goods and services, etc. Non-tax revenue consists of property income, and operating surpluses of departmental enterprises, receipts from public enterprises, voluntary unrequited non-repayable receipts other than from government, administrative fees and charges, fines, etc.

Government Current Expenditure

Current expenditure of government comprises expenditure on goods and services, interest payments and subsidies and other current transfers. It excludes capital expenditure.

Government Capital Expenditure

Capital expenditure comprises expenditure for the acquisition of land, intangible assets, government stocks, and non-military and non-financial assets as well as capital grants and lending minus repayments.

Overall Budget Deficit

The overall government budget deficit is total revenue, current and capital and official grants less total expenditure and net lending (minus payments).

Sources of Data

The main sources for the Central Government data were the reports and web sites of the Central Banks of the Member States and the Eastern Caribbean Central Bank.

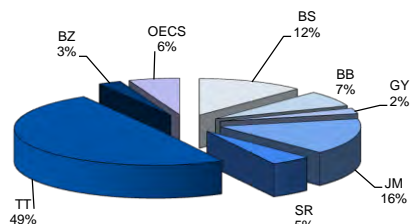

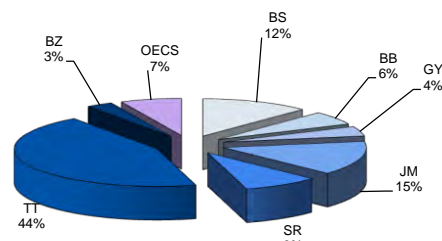

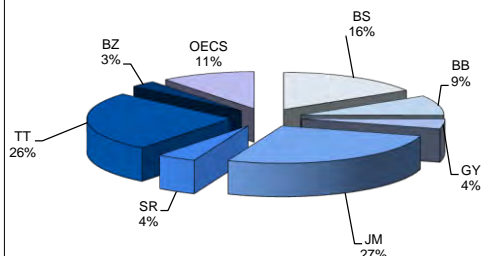
Member States' Shares of CARICOM's Total Exports of Goods and Services: 2006



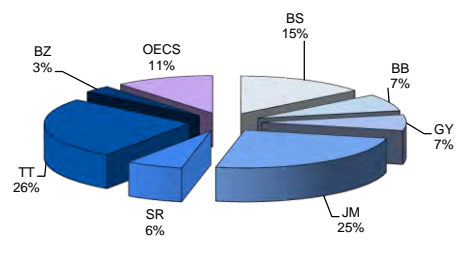
Member States' Shares of CARICOM's Total Exports of Goods and Services: 2010

Member States' Shares of CARICOM's Total Imports of Goods and Services: 2010

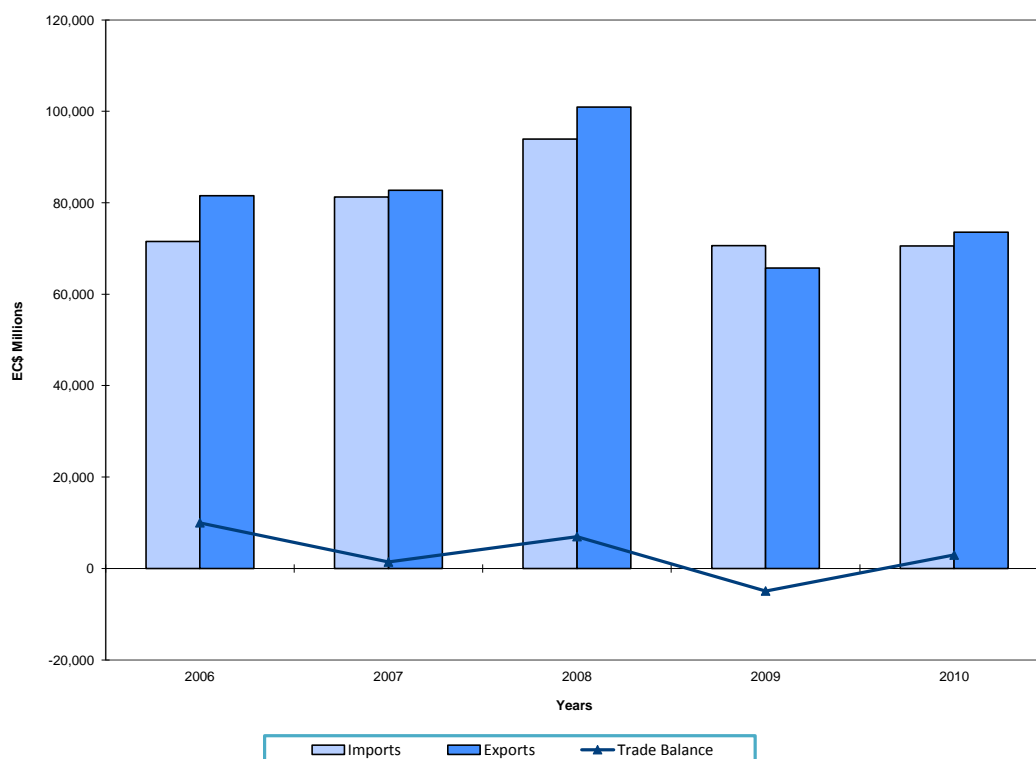

Value of CARICOM's Imports, Exports and Balance of Trade of Goods and Services: 2006-2010



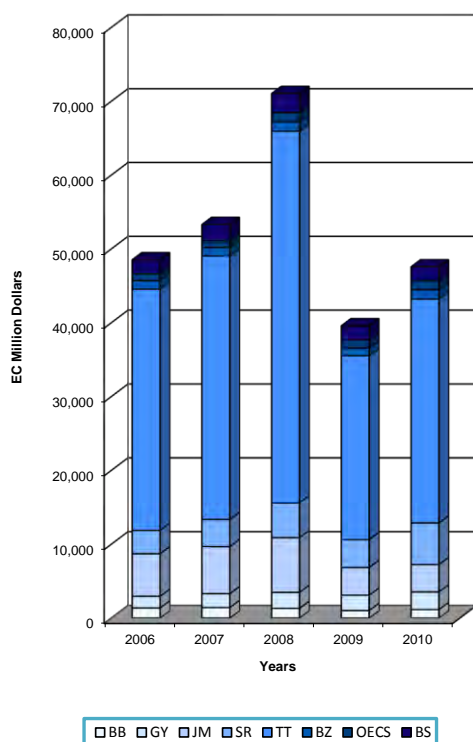

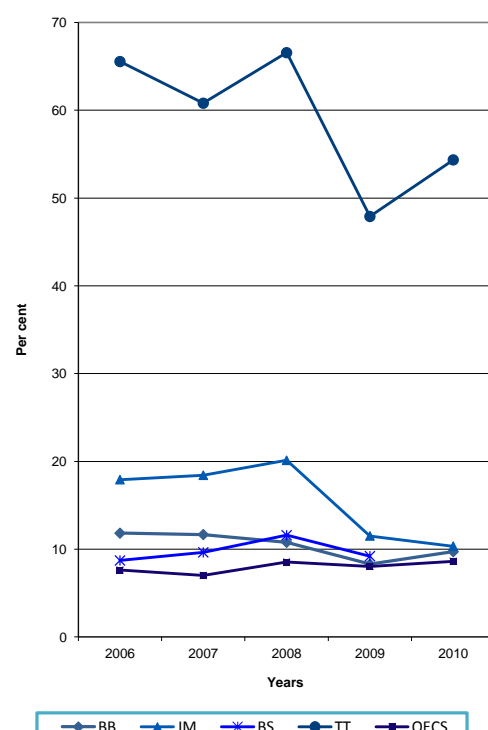

Selected Member States' Exports of Goods as % of Country's GDP: 2006-2010

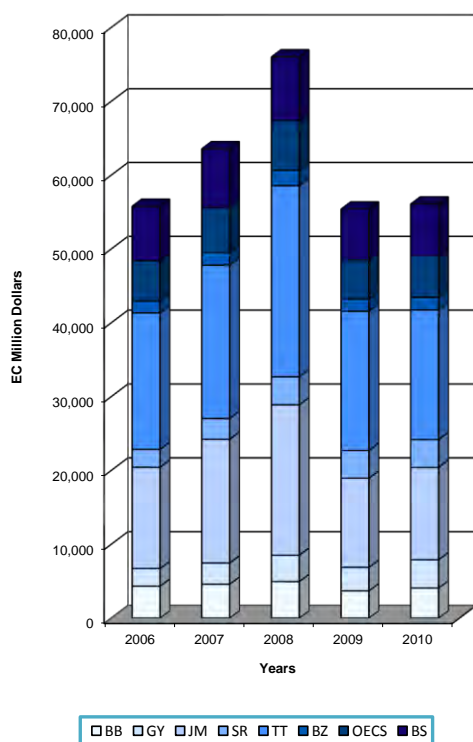

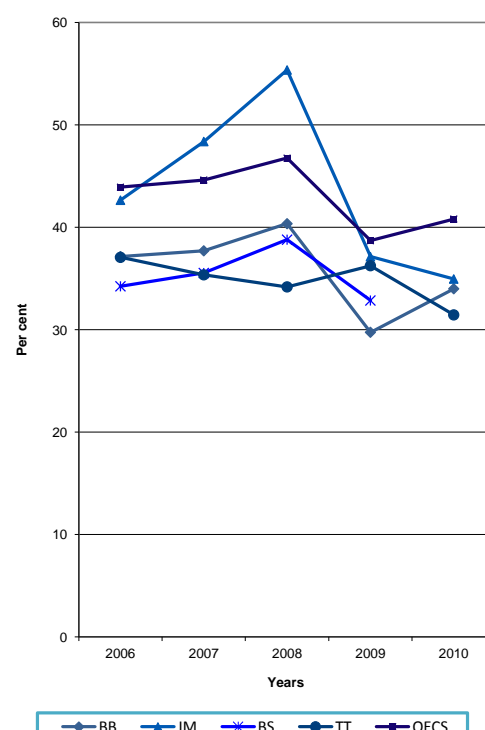

CARICOM's Imports of Goods: 2006-2010



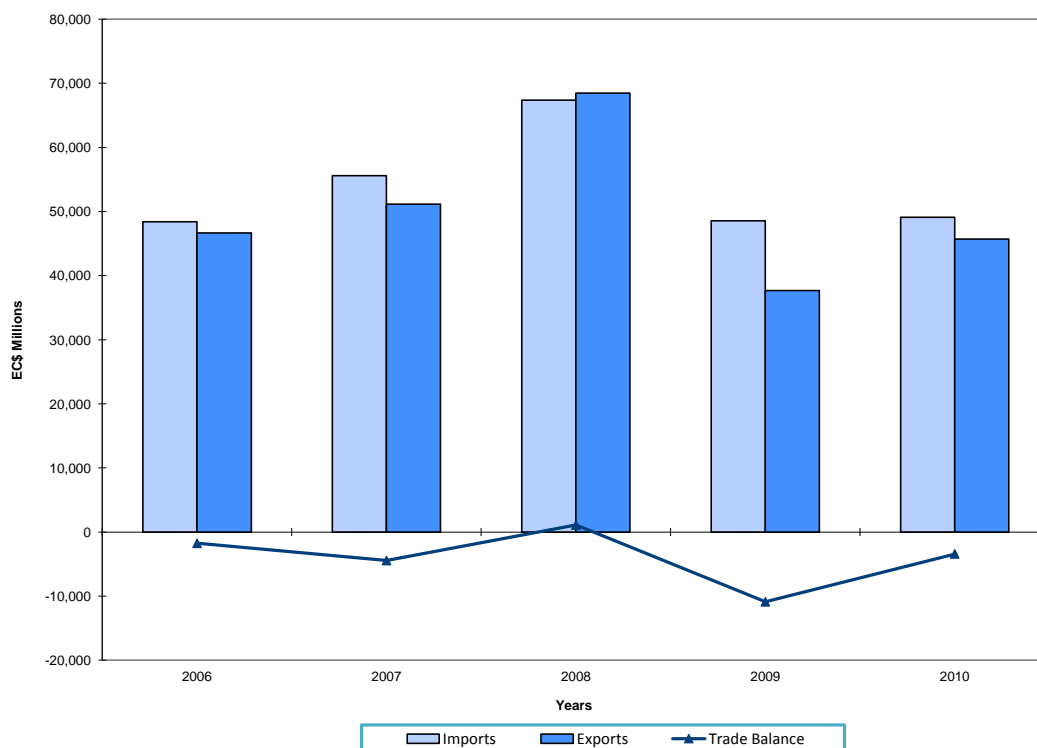

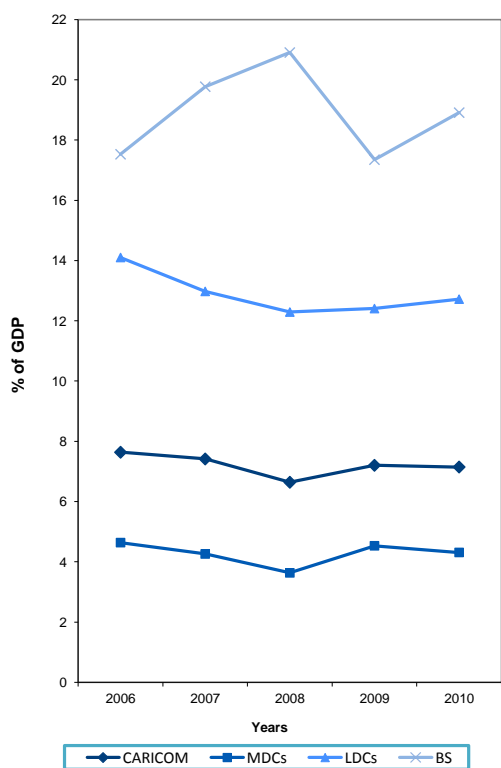

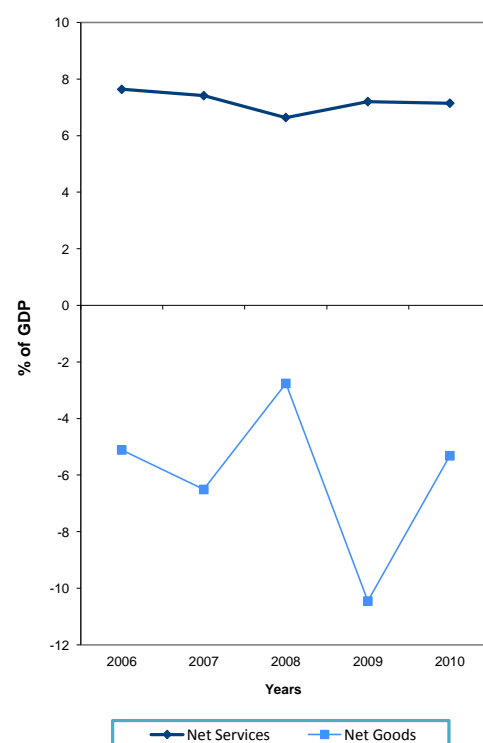

CARICOM - Net Services and Net Goods: 2006-2010



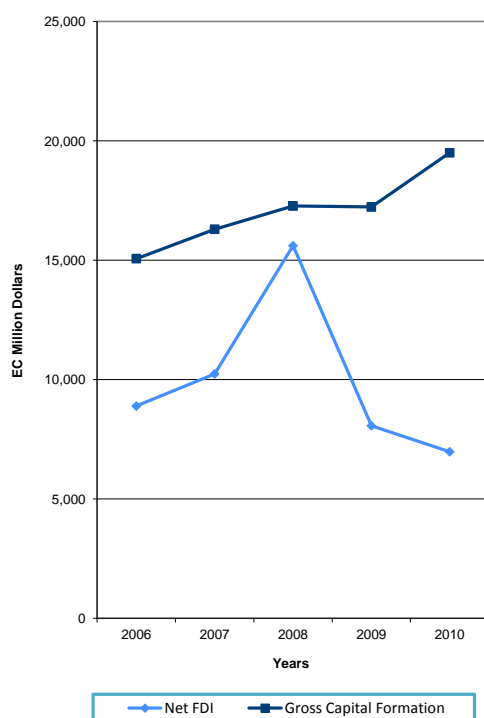

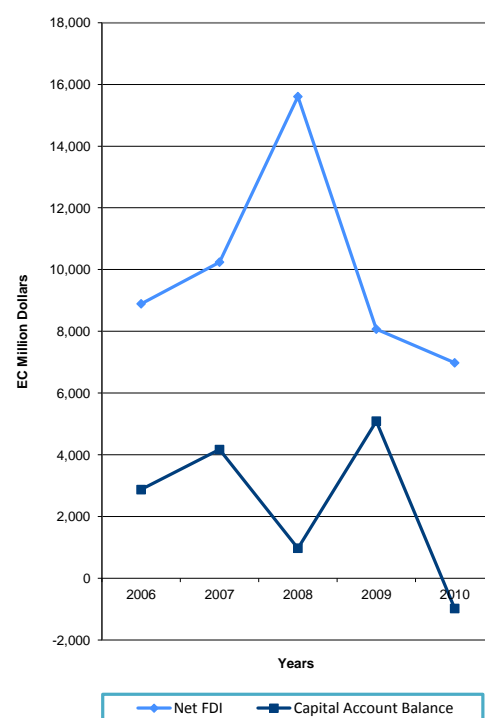

CARICOM - Net Foreign Direct Investment and Capital Account Balance: 2006-2010

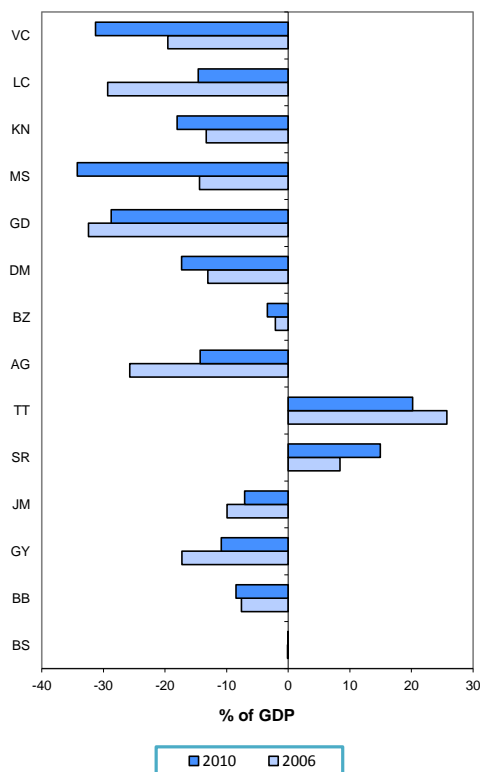

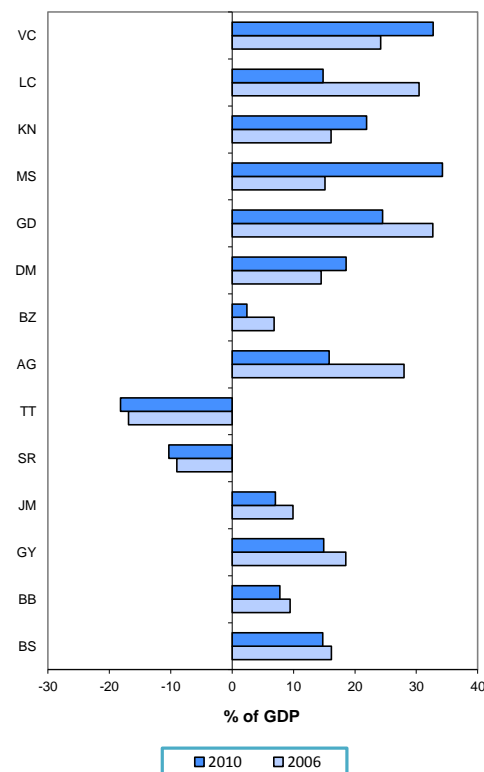

Capital Account Balance of CARICOM Member States: 2006 & 2010

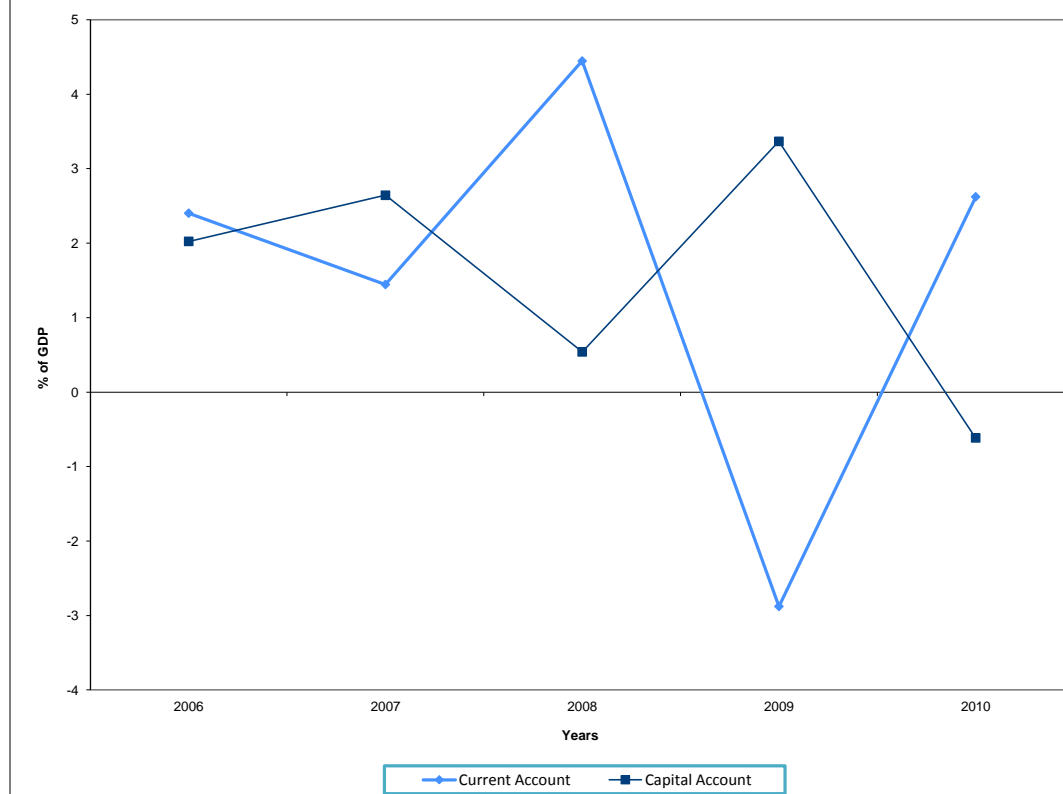

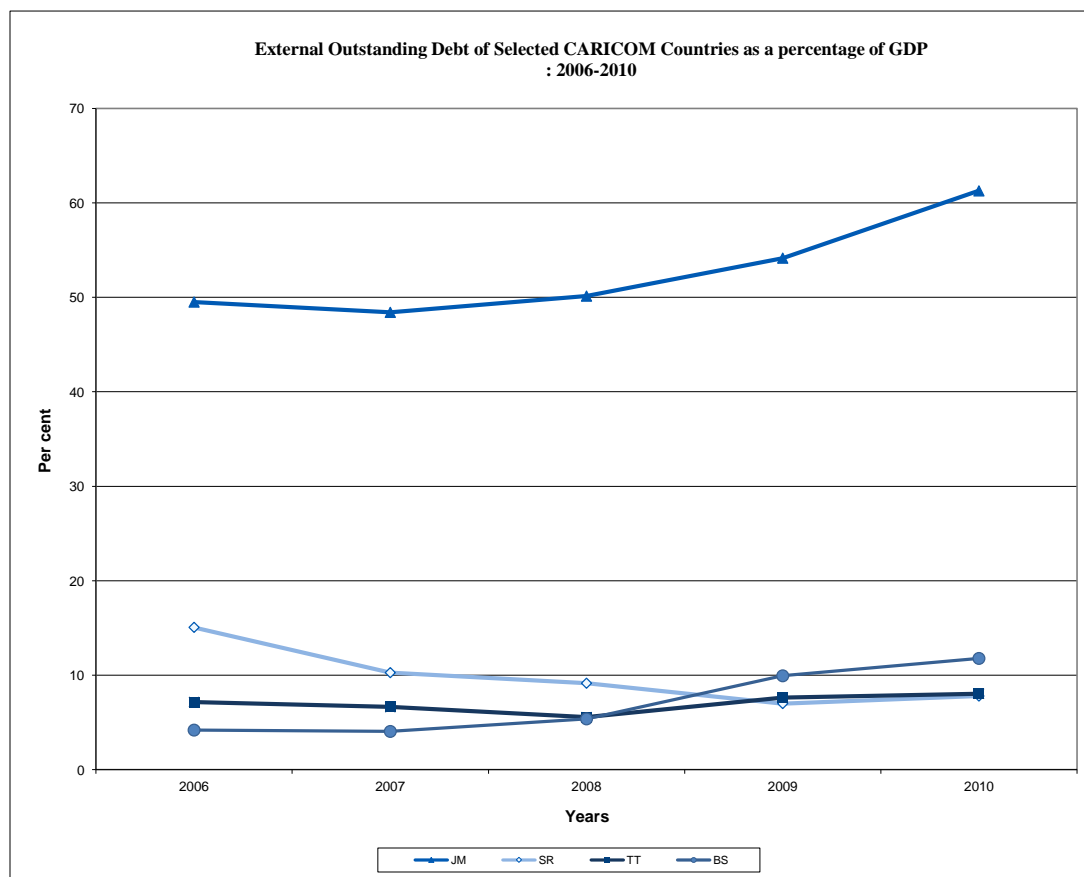

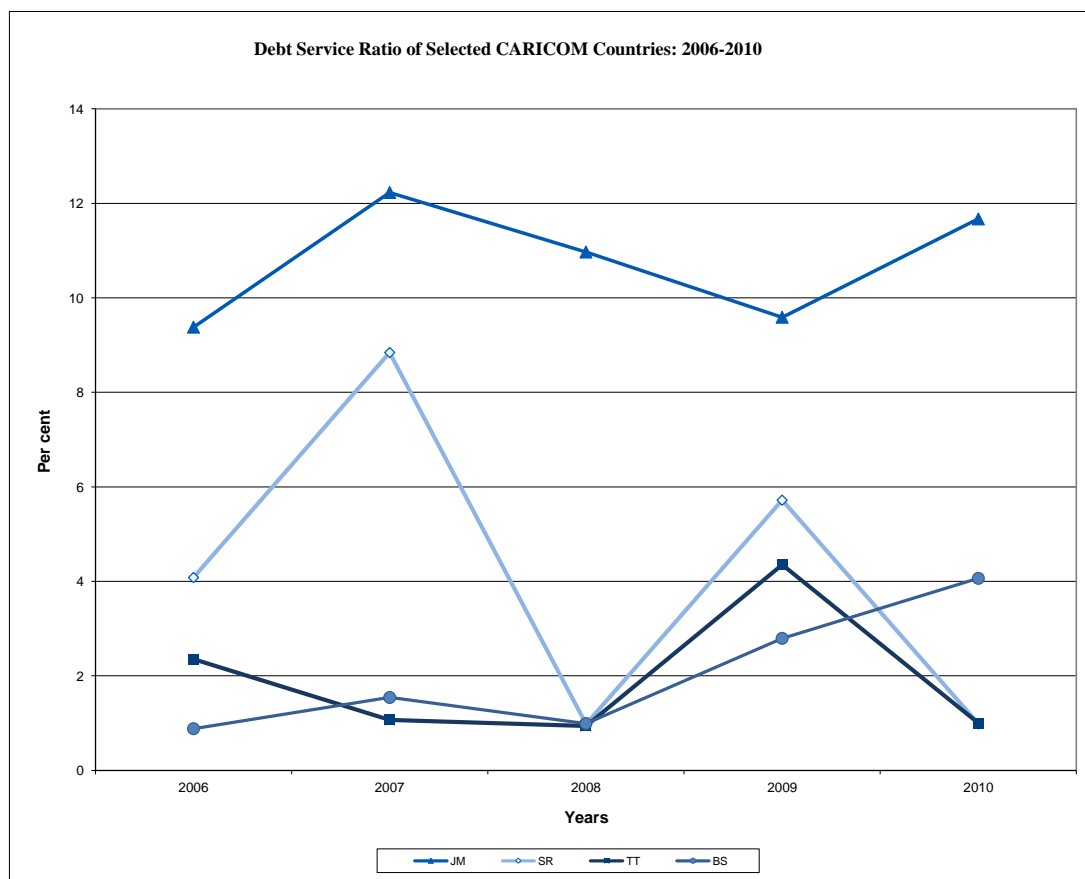

Notes about the data

Exports and Imports of Goods and Services

Merchandise (goods) trade data were extracted from the Balance of Payments of each Member State. Accordingly, the data are valued as free on board (fob) as recommended by the international balance of payments framework. The exception is Trinidad and Tobago which used the cost, insurance and freight (cif) valuation for their imports data. The trade balance is simply the difference between the exports and imports.

It should be noted that data on merchandise trade are originally captured by the Customs Department in each Member State and may differ from those in the Balance of Payments due to differences in valuation, classification, coverage and the timing of recording. As a result of these differences, the data in this Section will deviate from those presented in the *Selected Economic Indicators* summary table at the front of this report. The data that are provided in the summary table were extracted from reports based on data from the Customs Departments.

Net Foreign Direct Investment

The data presented in this table refer to the net inflows of foreign investment. Generally, for most Member States outflows are relatively small when compared with inflows. However, The Bahamas, Barbados, Jamaica and Trinidad and Tobago reported significantly more outward investment than the other countries.

Current and Capital Account Balances

Data for the Current Account Balance and the Capital Account Balance

were extracted from the Balance of Payments of the respective Member States.

External Debt and Debt Service Ratio

The ratio of External Debt Outstanding to GDP and the Debt Service Ratio are presented as reported by the relevant debt authority in the respective Member State. These may differ from similar ratios calculated by the reader based on the data in this report which might have been revised.

Gross International Reserves

There is only one Monetary Authority for the member countries of the Organisation of Eastern Caribbean States (OECS), namely the Eastern Caribbean Central Bank (ECCB), hence the Gross International Reserves of the member governments of this institution are pooled into one reserve. As a result, it is not possible to calculate the gross reserves of any one country. Rather, the reserves are given for the entire Eastern Caribbean Currency Union (ECCU) area, which includes the seven CARICOM Member States and Anguilla. It should be noted, however, that the foreign assets of commercial banks in Anguilla have been excluded from the gross reserves reported in this section.

The Gross International Reserves of Barbados and Trinidad and Tobago include the foreign assets of the Central Government.

Gross Official Reserves have also been presented where these data were available. The official reserves do not include the foreign assets of the commercial banks. In the case of Suriname, the gross official reserves excludes government foreign currency holdings at the Central Bank of Suriname, government foreign currency holdings at the commercial

banks, and Central Bank of Suriname's foreign currency holdings at the commercial banks.

Concepts and Definitions

Exports and Imports of Goods and Services

The value of exports and imports covers international movements of goods and non-factor services across customs borders. Exports are valued at free on board (fob) and imports at cost, insurance, freight (cif). Exports and imports of goods and services include all transactions involving a change of ownership of goods and services between residents of a country and the rest of the world, including merchandise goods and services.

Trade Balance

The trade balance is the difference between exports and imports of goods and non-factor services.

Foreign Direct Investment

Direct Investment refers to investment in which the investor has some kind of permanent interest in an enterprise located in a foreign country and exercises some control over its management. The non-resident investor holds or controls 10% or more of the voting stock.

Current Account Balance

The Current Account balance is the sum of net exports of goods and non-factor services (exports less imports), net factor service income, and net transfer payments. Official grants are included in this balance.

Capital and Financial Account Balance

The Capital and Financial Account balance comprises net capital transfers and acquisition/disposal of non-produced, non-financial assets, net direct investment, net portfolio investment, other net investment, including Public Sector Capital, and net reserve assets.

External Debt Outstanding

Total external debt outstanding includes all external obligation of both public and private debtors with maturity of more than one year. It comprises both public and publicly and privately guaranteed debt. This is therefore the total debt owed to non-residents of a country by a national government, public agency and other autonomous bodies as well as private guaranteed debt. This value divided by the GDP gives a picture of the total debt obligations relative to the productive capacity of a country. The higher this ratio is the greater the burden on future generations relative to the liquidation of this debt.

Debt Service Payments

Debt service payments are the sum of repayments of principal (amortisation) and interest actually made by a borrowing country in a specific year. The debt service ratio gives the total debt service payments to exports of goods and services, and reflects the percentage of foreign exchange earnings from exports that must be used to service the debt obligation each year.

Gross International Reserves

Gross international reserves is the sum of all the gross foreign assets of the Central Bank and commercial banks of a country. These include monetary

gold holdings, IMF Reserve Tranche Position, SDR's holdings and foreign currency balances.

Sources of Data

The data for these tables were extracted from the Balance of Payments tables of Member States which were prepared by the Central Banks of the Member States and the ECCB in the case of the OECS countries. External Public Debt data were supplied by the Central Banks or Ministries of Finance of the Member States. (See Appendix for a complete listing of sources.)

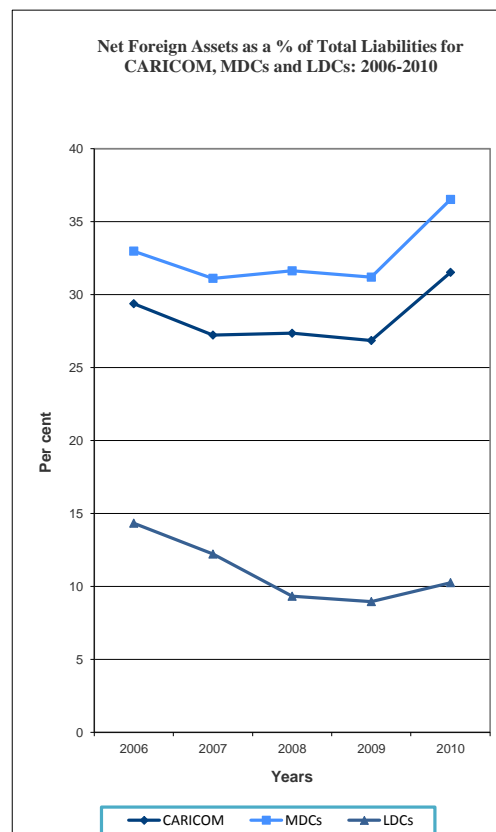
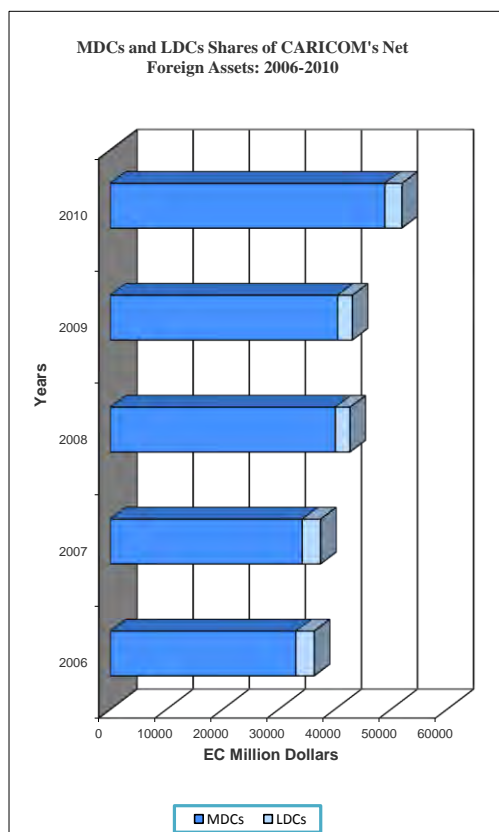

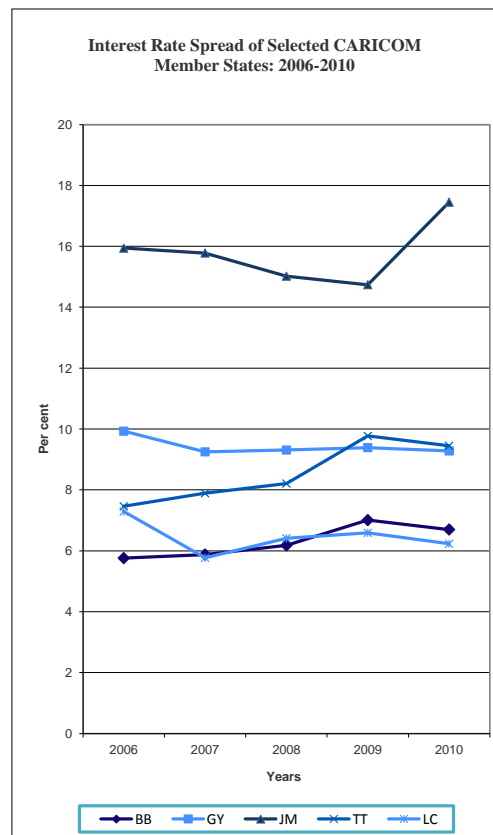
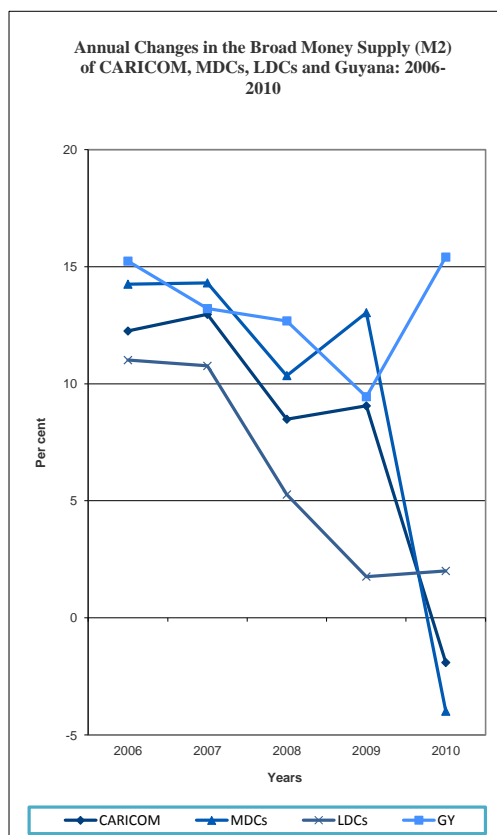
CARICOM, MDCs and LDCs' Domestic Credit to Private Sector as a % of Grouping's Total Liabilities: 2006-2010



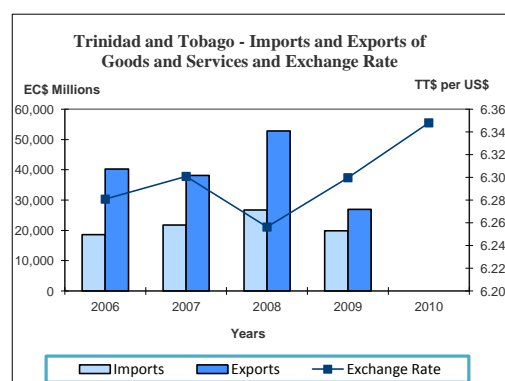
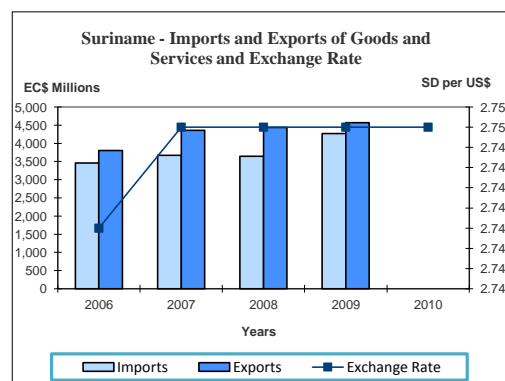
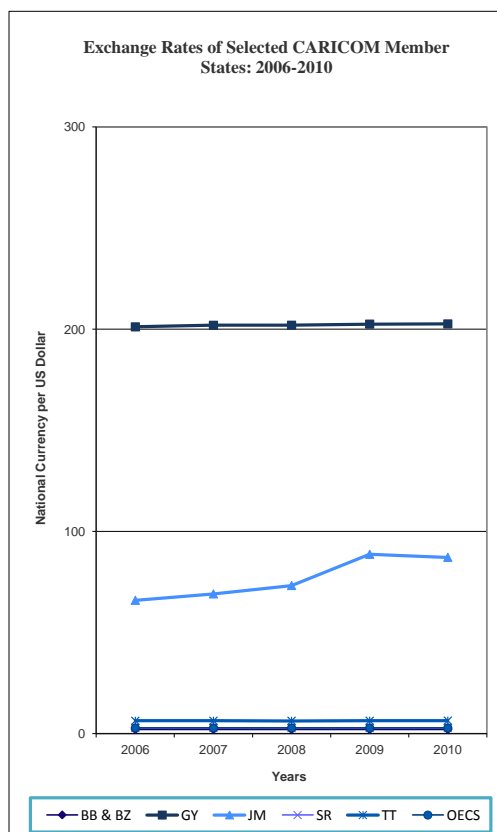
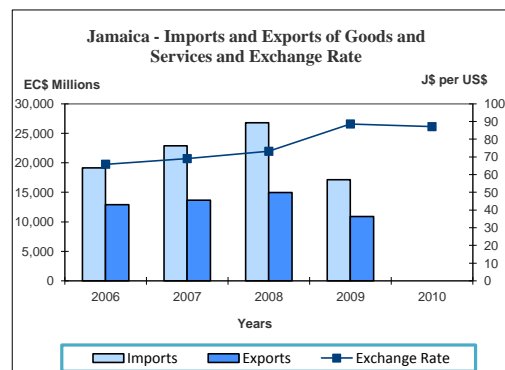
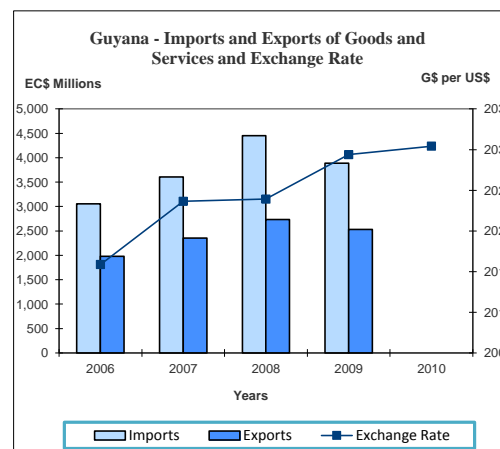
Selected Member States' Domestic Credit to Private Sector as a % of Country's Total Liabilities: 2006-2010

Notes about the data

For comparison purposes, these indicators were calculated as a percentage of the total liabilities of the Central Bank and commercial banks of the respective countries. However, since the OECS countries do not have individual central banks – they are members of the ECCB – the percentages were calculated using the total liabilities figure of the entire ECCU Area less the liabilities of the commercial banks in Anguilla.

Net Foreign Assets***Net Domestic Credit******Domestic Credit to Private Sector***

Data for The Bahamas were extracted from the Monetary Survey prepared by the Central Bank of The Bahamas. In addition to the Monetary Survey, the Central Bank also prepares a Financial Survey. The Financial Survey includes combined data from the Central Bank, commercial banks and other local financial institutions. The Monetary Survey, on the other hand, does not include data from the other local financial institutions.

Money – M2

The composition of this indicator varies among the Member States depending on whether or not foreign currency deposits by residents were included.

The OECS countries, The Bahamas, Belize and Trinidad and Tobago included foreign currency deposits by residents. Jamaica included foreign currency deposits but did not state whether this was by residents or non-residents. Guyana and Suriname did not state whether foreign currency deposits were included and Barbados excluded foreign currency deposits by non-residents from their Monetary Liabilities.

Interest Rate Spread

Guyana's interest rate spread was calculated as the difference between the weighted average lending rate of the Commercial Banks and the small savings rate. The small savings rate is an arithmetic average of savings deposit rates as reported by the Commercial Banks.

The interest rate spread for the other Member States were calculated from the weighted average interest rates for loans and deposits. Rates for Belize, Guyana, Jamaica and the OECS member countries were reported as at December.

In the case of Jamaica, Suriname and Trinidad and Tobago, the interest rate spread refers to local currency deposits and loans.

Nominal Exchange Rate

In 2004, Suriname changed its currency from the Suriname guilder to the Suriname dollar, the dollar being equivalent to a thousand guilders.

Concepts and Definitions***Net Foreign Assets***

The net foreign assets position is the total gross assets less total gross liabilities

Net Domestic Credit

Net domestic credit is the sum of domestic credit to the central government, public sector and private sector added to time, savings and foreign currency deposits and other items (valuations).

Domestic Credit to the Private Sector

The domestic credit to the private sector represents commercial banks'

investment in time deposits, marketable stock, other private sector securities and total loans to the private sector.

Money Supply – M2

Money supply, M-2, is defined as the sum of currency in active circulation, commercial banks' reserves with the Central bank, demand deposits, savings deposits and time deposits.

Interest Rate Spread

The difference between the weighted average interest rates on loans and deposits is the interest rate spread.

Nominal Exchange Rate

The nominal exchange rate is the country's official exchange rate to some other country's currency, in this case, the US dollar. The exchange rate may be fixed and is therefore determined by the official authorities. The exchange rate can be flexible or floating, determined by the market forces or might be managed floating.

Sources of Data

These data were taken from the Central Bank reports of the respective Member State or from direct contact with the Central Bank.
